Case types (approximately 27 types based on current jurisdiction) are divided into categories, based upon complexity and normal length of time between the filing of a case to final disposition. The objective is to dispose of the cases within 90 days, 120 days or 180 days or maintain an average of less than 90, 120 or 180 days for each type. The total number of cases disposed of in FY 07-08 was 1,911. See "Age of Disposed Cases Report" for avg. disposal rate for each case type.
