



TO: Members of the South Carolina General Assembly

It is my pleasure to transmit herewith the 1993 South Carolina Economic Report as prepared by the Board of Economic Advisors.

The most exciting piece of economic news during the past year was the decision of Bavarian Motor Works (BMW) to locate a North American manufacturing facility in the Upstate region of South Carolina. The State's skilled labor force, competitive wages, favorable real estate values, and accessibility to markets in the Southeastern region and throughout the nation were decisive factors in the BMW decision. The South Carolina location enables BMW to build, market, and distribute its high quality product within a competitive environment which insures manufacturers favorable conditions in which to invest and prosper.

In 1992, South Carolina income growth matched the pace of income growth nationally; however, as the effects of the 1990-91 recession diminished, South Carolina outpaced the United States in employment growth. The State added 15,700 workers to payrolls and expanded employment by 1.0%, ten times the rate of U.S. employment growth. During the past six years, nearly \$18 billion has been invested in industries in South Carolina. In 1992, two-thirds of total investment in new and expanded industrial facilities was concentrated in the metalworking and chemical industries. Furthermore, the year marked the third highest level of investment in new and expanded facilities, during which 15,313 jobs were created to maintain South Carolina's competitiveness.

As geographic borders change and trade barriers are relaxed, the citizens of the Palmetto state continue to meet the economic and social challenges in an internationally interdependent society and are ready to accept the dynamic role in this new world environment.

OVERVIEW OF THE ECONOMY IN 1992

Overview

Following the recession of 1990-91, South Carolina's economy began to recover during 1992, but only at a very slow pace. Normally, after a recession the economy recovers with a spurt, but that did not happen in 1992.

Because the recession lasted so long and the recovery in 1992 was very slow, the Federal Reserve pushed interest rates down to their lowest levels in nearly twenty years. Lower interest rates helped to put consumers and businesses back on their feet. Consumers regained some confidence and started to buy goods again, increasing sales by businesses.

Taking advantage of lower interest rates, businesses refinanced debt to reduce interest costs. They also upgraded their equipment to become more efficient. In South Carolina, businesses invested \$2.8 billion in new plants and equipment in the State, the third largest in history. Moreover, a lower value of the dollar against European currencies helped them increase their sales relative to foreign competition.

The general improvement in the economic climate in the state helped businesses to begin hiring again in 1992. Whereas they had reduced jobs 31,600 during 1991, they hired 15,700 in 1992, making up one-half of the job losses that occurred during the recession.

Some of the 1991 job losses will not be regained because businesses upgraded their equipment and became more productive. Nevertheless, output of manufacturers in the state increased in 1992 even though there were fewer workers than in 1990.

As one might expect, job gains and losses varied considerably among the different sectors of the state's economy. Most of the job gains in 1992 were in private services, retail trade, and local schools. The state also hired to staff new prisons. And manufacturing added some employees despite buying new, more efficient machinery. On the other hand, the construction industry continued to have huge layoffs. The job gains and losses are summarized in the table on the next page.

More jobs plus higher salaries for those already working caused a recovery of income growth and the tax base of the state. During the 1991 recession, the aggregate of all wages of the state's workforce grew only 2.3 percent, which was the underlying cause of the General Fund Revenue shortfall that the state incurred during fiscal year 1990-91. But with the recovery in business conditions and employment during 1992, wages grew 4.2 percent. Nevertheless, wage growth in 1992 was less than its average in South Carolina of 6 to 7 percent, leading to weak growth in General Fund Revenue in fiscal year 1991-92.

The economic well-being of the citizens of the state also recovered in 1992. During 1991, per capita income grew only 2.4 percent compared to an inflation rate of 4.2 percent. In real terms, the wealth of the citizens of South Carolina actually declined in 1991 because it was eaten away by inflation. In 1992, on the other hand, per capita income grew by 3.9 percent, which was more than the inflation rate of 3.0 percent. The 1992 recovery regained most of the real wealth lost during 1991.

Growth in wages was uneven among the sectors of the state's economy. The service sector led the recovery with wages growing 8.8 percent, closely followed by manufacturing and retail trade. Income growth in most of the other sectors was relatively weak. Because of the falloff in commercial building, construction workers actually received 5 percent less income than in 1991. Growth in aggregate income for state employees was only 2.7 percent, despite adding employees for prisons.

A significant part of the state's income base derives from nonwage sources. Except for welfare payments, the nonwage income in the state was relatively weak. Earnings on interest, investments, and rental income by the state's citizens fell 2 percent in 1992, whereas they normally rise quite well. Social Security payments to retirees rose 4.5 percent in 1992. Boosted by large Medicaid increases and a rapid expansion of the welfare rolls during the recession, welfare payments increased 12.9 percent. Welfare payments include government checks to recipients of such programs as Aid to Families with Dependent Children (AFDC), Medicaid, and Food Stamps.

Manufacturing

Despite a recovery from the recession at the national level, the manufacturing sector of South Carolina did not bounce back very fast in 1992. Weak national demand for autos, furniture, and textiles kept the state's manufacturing sector from recovering very fast.

Slow growth in manufacturing had a significant impact on the state's economy in 1992, because manufacturing was the most important sector in the economy of South Carolina. Nearly one out of every four workers in the state was involved in manufacturing, significantly above the national share of 17 percent. Textiles continued to be the most important manufacturing industry in the state.

Manufacturing employment grew by a modest 1,500 jobs in 1992 after declining by more than 14,000 in 1991. Most of the employment growth was in the apparel and chemicals industries. The net increase

in manufacturing employment occurred despite the use of better equipment in manufacturing.

In order to meet foreign competition, the manufacturing sector continued to make huge investments in facilities and equipment during 1992, despite struggling through the recession of 1990-91. According to the South Carolina State Development Board, investment in new and expanded industrial facilities in the state totaled \$2,879.1 million during 1992. Investment was heaviest in metalworking, chemicals, and textiles, accounting for 75 percent of total investment in the state. Metalworking accounted for a record high of \$1,091.7 million, an increase of 125 percent over 1991 investment levels. Investment in chemicals and allied products was also strong, topping \$800 million. The total number of new or expanded firms in 1992 was 665, of which 73 were new facilities, which employed a total of 15,313.

Although the economy of South Carolina has become increasingly more diversified, the manufacturing sector continues to dominate the state's economy. The top ten manufacturers in the state alone employed over 40,000 workers. The Westinghouse Savannah River Site and the Charleston Naval Shipyard accounted for a sizeable portion of the state's manufacturing base. During the 1980's, the Federal government beefed up staffing at these facilities, but began cutbacks there in 1992. Both are at risk of being phased out. The loss of the top two manufacturing employers in the state would sharply reduce personal income and tax revenue collections in succeeding years.

Services

The bulk of new jobs added in 1992 was in the service sector, which expanded by 12,900. Because of rapid growth in the Medicare and Medicaid programs, health services were a leading growth industry in the state, adding 3,700 jobs in 1992.

Because of the national recession, the South Carolina tourism industry had a difficult year in 1992. Employment in hotels barely increased over 1991 levels. Total accommodations taxes actually fell 1.9 percent during fiscal year 1991-92, suggesting there was little new spending by tourists along the coastal areas. The state has historically depended on growth in tourism, but was not able to in 1992.

Trade

In 1992, retail trade added 6,100 jobs, while wholesale trade declined by 1,500, for a net employment gain in the trade sector of 4,600. Most of the job gain was in grocery, lumber and building materials stores. Lower interest rates induced families to remodel or expand their existing homes. Moreover, the state's retailers enjoyed their first decent Christmas in three years with sales up 9 percent during the holiday season.

Construction

Construction in South Carolina lost 7,300 workers in 1992, an 8.3 percent decrease in employment from 1991, after losing 13,500 a year earlier. Even though interest rates were lower, banks were not anxious to lend to builders for many new construction contracts, particularly for commercial construction. Although residential building increased a little in 1992, commercial and industrial building went into a deep slump. Construction work at the Savannah River Site to rework the old reactors also tailed off in 1992.

The number of single-family housing permits issued in 1992 rose 9.4 percent over those issued in 1991, but permits for commercial structures decreased 7.1 percent, and apartment building permits declined 12 percent in 1992.

Finance, Insurance, and Real Estate

During 1992, bank mergers, adversely affected employment in the finance sector. The finance sector in South Carolina grew throughout the 1980's, but major financial centers in Atlanta and Charlotte took over several of the leading banks in the state. Employment in this sector decreased in 1992 by 900 jobs.

During 1991 and 1992, three major bank mergers reduced the number of commercial banks in the state. On December 18, 1991, South Carolina National Bank was acquired by Wachovia Bank of Winston-Salem, North Carolina. On June 19, 1992, C&S Bank was bought out by NationsBank of North Carolina. On September 28, 1992, First Union of North Carolina merged with South Carolina Federal.

Total assets of commercial banks operating in the state in 1992 were \$25.0 billion, which was down from \$25.5 billion at the end of 1991. The five leading banks at the end of 1992 are listed in the following table. The bank mergers made NationsBank the largest commercial bank operating in the Palmetto State, with assets of nearly \$9 billion (see Table 6).

Savings and loan banks had another bad year in 1992. Their assets shrank from \$10.5 billion in 1991 to \$10.1 billion in 1992, or by 3.5 percent. Much of the decline was because of the bailouts of the savings and loan banks by the Federal government. Also, during 1992 savings deposits decreased by 3.1 percent.

Credit unions continued to increase their market share. At the end of 1992, there were 114 credit unions in South Carolina. The

total number of credit unions in the state has declined every year since 1978 when 202 credit unions were operating in South Carolina, but at the same time, credit union membership has steadily grown. In 1970, membership in credit unions totaled 196,839. At the end of 1992, membership stood at 769,680. Savings, loans, and assets of credit unions have all increased since the early 1980's.

The insurance business has been a fast growing segment of the state's economy. The value of life insurance premiums received in 1991 totaled \$1,010.8 million, compared to a 1990 total of \$984.3 million. The value of accident and health premiums received in 1991 equalled \$1,069.8 million, while those received in 1990 came to \$1,051.3 million. The value of insurance property premiums written in 1991 was \$2,735.7 million, and the value of those written in 1990 was \$2,637.0 million.

Transportation, Communication, and Public Utilities

Employment in the transportation, communication, and public utilities sectors declined by 1,400 employees, or 2.1 percent, in 1992. Electric, gas, and sanitary services reduced employment 400 jobs due to improvements in efficiency.

Trucking and warehousing activities were enhanced by the construction of distribution centers throughout the state. Over 500 jobs in transportation, communication, and public utilities were generated by new distribution centers and the trucking and warehousing activities associated with these centers.

The lack of a commercial airline hub in South Carolina and competitive price slashing of air fares by major airlines has hurt the air transportation segment. The bankruptcy of Eastern airlines and the cancellation by Lufthanza of transatlantic flights to Germany negatively affected employment in the sector. Employment and service cutbacks by Delta, Continental, U.S. Air, and United from regional airports within the state negatively affected employment in the sector.

Government

During 1992, local government, which includes cities, counties, towns, and school districts, was one of the leading sources of growth in the state, adding 6,000 jobs. School districts added teachers to meet the needs of the state's rapidly rising student enrollment. In 1992, enrollment increased by over 5,000 students. The cities and towns also beefed up law enforcement and fire protection.

The State added 2,400 employees in 1992, nearly all of which was to staff new prisons, meet the requirement of expanded state health service, and to enhance faculties and reseach at the universities.

The Federal government cut jobs by 2,200, most of which were at the Charleston Naval Shipyard. Some small cuts were also made at the Savannah River Site and other Federal agencies scattered throughout the state.

Agriculture


Trends over the past two decades in agriculture show that in both the United States and South Carolina farm real estate prices have risen and the number of farms and land in farms has fallen. After farm real estate prices plunged in 1986 to \$870 per acre, the average value of land per acre has slowly recovered to \$931. Total farm acreage has fallen steadily from 8,200,000 in 1971 to 5,200,000 in 1992, and the average size of a farm in South Carolina is 24 acres larger in 1992 than in 1980.

OVERVIEW OF STATE FINANCES IN 1992

Revenues

During FY 1991-92, the recession continued to have an unfavorable impact on General Fund Revenues. For the second year in a row, General Fund Revenues hardly grew at all -- just 1.1 percent. As shown in Figure 1, General Fund Revenues in FY 1991-92 were just barely above their level two years earlier.

The state's leading source of revenue, the Individual Income Tax, performed poorly in fiscal year 1991-92. The loss in jobs in 1991, the poor business conditions for the self-employed, and a large decline in interest earnings, curtailed receipts under the Individual Income Tax. The tax grew only 1.7 percent over the previous fiscal year. Because those who held on to their jobs during the recession received pay raises, withholdings rose 4.2 percent. But quarterly declarations filed by the self-employed and people living off interest earnings fell 2.0 percent. And year-end payments, which are mainly paid by self-employed businessmen, fell by 10.1 percent.



The Sales Tax, the second leading source of revenue, performed even more poorly than the Individual Income Tax, growing less than one percent in FY 1991-92. Strapped by high debt, consumers limited their purchases in FY 1991-92 and paid down some of their auto debt and charge card balances. Poor conditions in the construction industry reduced sales taxes on building materials by approximately 25 percent.

Together, the Individual Income Tax and the Sales Tax, which accounted for over three-fourths of General Fund Revenues, grew only 1.4 percent. As the following figure shows, sales and income taxes were flat in FY 1990-91 and FY 1991-92.

Other revenues collected from businesses such as those on corporations, alcoholic liquors, beer and wine, cigarettes, soft drinks and contractor licenses actually declined in FY 1991-92. Part of the decline was because of the recession. The Corporation Income Tax, for example, dropped 7.2 percent. But a large part of the decline was not necessarily related to the recession. Most of these other sources of revenues are based on fixed tax rates which have not been increased in years, such as the cigarette tax which has been 7 cents a pack for over 20 years. Because the rates are fixed, any cutback in usage reduces revenue. Cutbacks in smoking and alcoholic beverage usage by consumers reduced collections for two of the state's larger sources of revenues. Overall, taxes collected from businesses, declined by 0.1 percent in FY 1991-92. As the above figure shows, taxes paid by businesses have actually fallen the last couple of years.

Expenditures

Appropriations by the State for FY 1991-92 were targeted at meeting the state's pressing needs in health care and corrections. Other activities of state government were appropriated smaller increases, or decreases.


The falloff in revenues because of the recession caused the State to make significant cuts in FY 1991-92. The State appropriated \$3,583 million for FY 1991-92, which was based on estimates of normal growth made in February 1991. But by July 1991, which was the beginning of the fiscal year, it had become increasingly clear that the state was not recovering from the 1990-91 recession very well and it was unlikely that revenues would grow like normal.

In July 1991, the Board of Economic Advisors made a \$148 million reduction in the revenue estimate. The Budget and Control Board (B&CB) responded by eliminating the \$65.9 million appropriation for the Capital Reserve Fund and ordered that another two percent be set aside by agencies as a reserve. In February 1992, the Board of Economic Advisors (BEA) made another \$55 million reduction in the estimate. The B&CB responded to the second lowering of the estimate by eliminating the \$23.0 million reserve, taking \$38 million out of the General Reserve Fund, and cutting agency carry forwards by \$21 million.

The impact of the cuts on many agencies was severe. Actual spending for education was 2.9 percent lower in FY 1991-92 than in FY 1990-91. The executive and administrative agencies and Social Services were reduced by 6 percent. Spending for health care, corrections, the judicial department, and Aid to Subdivisions increased despite the cuts.

On balance, actual spending from the General Fund was reduced 1.6 percent in FY 1991-92 from its level in FY 1990-91. As shown in the following figure, spending on health has been increased significantly since 1984, more than doubling. Spending for corrections has also risen constantly. But spending for education declined in fiscal year 1991-92. And spending for all the other functions of government was reduced for the second year in a row.

Fiscal Year 1992-93 Estimate


On October 10, 1991, the BEA submitted its first official estimate for FY 1992-93 General Fund Revenue of \$3,625 million. Because the economy was not recovering as anticipated, the BEA reduced that estimate by \$70.0 million to \$3,555 million on February 10, 1992 while the General Assembly was still considering the FY 1992-93 budget. The General Assembly adopted various revenue enhancements, increasing the estimate by \$207 million to \$3,762 million.

By August 1992, shortly into the FY 1992-93 budget year, the economy still had not spurred forward as it usually does after a recession. On August 21, 1992, the BEA reduced the \$3,762 million General Fund estimate by \$195.0 million to \$3,567 million. The BEA lowered the estimate for the revenue enhancements by \$28.6 million and lowered the \$3,555 million BEA base estimate by \$166.4 million.

The BEA met on November 9, 1992 to update the estimate for FY 1992-93. The BEA did not alter its August 1992 revised estimate for FY 1992-93 because revenue trends through October were on target to achieve the estimate. The BEA met again on February 11, 1993 to present the final forecast for FY 1993-94. Revenue collections through January in FY 1992-93 were approximately \$25 million in excess of the schedule needed to meet the \$3,567 million estimate for the full fiscal year. The BEA made no adjustments to the either the FY 1992-93 or the FY 1993-94 estimate.

Through May 1993, which was the last month of available data, revenues were ahead of schedule to meet or exceed the \$3,555 million estimate for FY 1992-93.
