RECIPIENTS OF FUNDS	These funds will be used to recover lost firefighting capacity by refilling vacancies for frontline firefighters, supervisors of frontline firefighters, foresters who provide critical IMT command and logistic support during wildfires, dispatch/communications personnel, and an arson and timber theft investigator. A small portion of these funds (\$130,000) would be used to provide frontline firefighters (only) with a two percent pay increase. Frontline firefighters are among the lowest paid state employees but incur great risk. They were not included when increases were given to law enforcement last year. This request would restore 15 firefighter positions lost due to budget cuts and return the total to 160. This number is needed for average fire seasons. Therefore, the state is within 10% of goaled fire units.

SUMMARY
 The Commission is very grateful for funding received the past two years which has helped the agency begin to recover from previous devastating reductions to its budget. However, the Commission's service capacity is still inadequate to meet its protection and development mission safely. The Commission still needs to fill additional positions to operate safely and protect South Carolina citizens and property. While the number of fire suppression personnel has risen the past two years with improved budgets, this number is still below goal and keeps lives, homes and timber investments in great danger and endangers the lives of firefighting employees as well. The state's total number of public and private firefighting units in the state dropped from 240 to 134 over the past fifteen years. While the state no longer needs 240, the agency feels that approximately 160 is an adequate number to provide sufficient protection in average fire seasons. Field personnel now cover much more geographic area than in the past and continue to take on additional duties.
 Quick and accurate dispatch of firefighters and radio communications is essential to the Forestry Commission's wildland fire protection responsibilities. South Carolina's population continues to expand into forested areas, further increasing the risk of homes and lives due to wildfires in the Wildland Urban Interface (WUI). Wildfires destroy an average of 40 homes each year in South Carolina. The Commission investigates all reported arson, timber theft and timber transaction crimes on state and private lands. Three full time Investigators are trained in technical forestry issues including arson investigation cases, and one more is being requested. Investigators also enforce timber theft and fraud and typically recover 70% of stolen value which averages about \$500,000 annually to small private landowners.

INTENDED IMPACT	<p>This decision package will provide for adequate protection of the firefighters, citizens and property of South Carolina during <u>average fire seasons</u>. The agency's firefighting capacity was been severely diminished over past years through budget reductions. Funding received in the past two years has helped to begin restoring some of that capacity lost. In 2009, the state was fortunate to survive the worst wildfire in state history without a fatality. However, 20,000 acres were burned, over 70 homes destroyed and hundreds of lives displaced before the fire could be contained with damages exceeding \$50 million. The Forestry Commission is committed to the protection of lives, homes and property and to be ready for fires of this magnitude in the future. Average fire seasons produce about 3,000 wildfires, but bad seasons have produced over 10,000 fires in a year and will greatly exceed Commission capacity even when the goal of 160 manned fire units is attained.</p>

RECIPIENTS OF FUNDS	The Forestry Commission has collected field data from 3,500 permanent plots in South Carolina since 1998 for use by the USDA Forest Service Forest Inventory and Analysis (FIA) program. FIA is used to manage South Carolina's forest resource and guide its economic development. Federal funding covers 75% of the cost of the program but this percent is scheduled to decline. The agency is required to match the federal funds on a 75 / 25 percent basis. Because of past reductions, the agency has used funds from landowner reforestation programs to cover this match. The agency needs to stop using landowners' program funds (\$130,000), so they can be used to grow more trees. Approval of this budget line item will secure dedicated state matching funds specifically for this program that is critical to forestry-related resource decisions and economic development. The agency will also use operating funds (\$200,000) to retain and grow the secondary high value-added manufacturing segment of forest industry to add more well-paid jobs without needing more wood production.

SUMMARY	<p>The Forestry Commission has collected field data from 3,500 permanent plots in South Carolina since 1998 for use by the USDA Forest Service Forest Inventory and Analysis (FIA) program. This FIA program provides critical data to industry investors who are looking to make capital investments and locate wood manufacturing companies and jobs in South Carolina. South Carolina’s forest resource supports a \$17.4 billion economic impact to the state’s economy that is growing with help from the Commission led 20/15 project. Forestry is South Carolina’s leading manufacturing industry in terms of jobs (90,000) and wages. Our forests also impact the economy by improving water and air quality as well as the quality of life in South Carolina. The Forestry Commission, as mandated by state law (48-23-90) is the agency designated to collect forest resource data in South Carolina. Forest resource data and associated analyses are critical to growing both existing and new forest industry in South Carolina. These industries require accurate, up to date forest resource information, and FIA is the only inventory system in place to provide this data. The agency needs a dedicated and stable source of funding for this program to enable it to compete with other states in growing our forest industry. Federal funding currently covers 75% of the cost of the program but funding is expected to decline. The agency is required to match the federal funds on a 75 / 25 percent basis. Because of past reductions, the state’s 25% commitment has been funded from a landowner reforestation program to allow the agency to use existing funds to maintain firefighting capacity. Approval of this budget request will provide dedicated funding specifically for this program that is critical to forestry-related economic development and job growth.</p> <p>The agency has had to rely on federal grants to carry out critical functions in support of our 20/15 Initiative to grow the industry to \$20 billion by 2015 and other forestry-related economic development. Ongoing work in this area include maintaining mill directories, conducting mill surveys, conducting special studies related to the forest resource, publishing forest resource reports, and targeted marketing to grow new markets for South Carolina products. INTENDED IMPACT	<p>This decision package is intended to increase the economic impact of forestry in South Carolina from a \$17.4 billion industry to \$20 billion and providing 12,000 additional jobs with wages higher than the state average and increasing exports above the current \$1.4 billion. It will also help maintain forestry as the #1 manufacturing segment in the state in regards to jobs and wages as well as the #1 cash crop and #1 Charleston port export. The SC Forestry Commission is the sole source of detailed forest resource information and state supplied resource analyses. Up-to-date, accurate forest resource data is critical to expanding the forest industry. SUMMARY	<p>The genetic improvement of forest trees has existed since 1957 through members of the NC State Tree Improvement Cooperative. The State of South Carolina through the Forestry Commission participated in this cooperative for 41 years from 1963 – 2004. Because of budget reductions the agency was forced to sever its membership in the cooperative. When compared to agricultural crops, improvements in both production and wood quality of forest trees takes much longer and needs consistent, continual work. The future of the \$17.4 billion forest products industry and its 90,000 jobs hinges on producing more wood on fewer acres. SUMMARY	<p>The Forestry Commission's fire suppression equipment replacement budget now has a stable baseline with the passage of Act 271, in 2012. This act gives the agency a reliable baseline of annual funding to replace firefighting equipment over the next five years and help maintain a safe 15 year dozer replacement cycle <u>after the backlog</u> of old units is replaced. These funds will purchase about eleven tractor/plow units annually. With a current inventory of 165 suppression units, 71 of which are already past 15 years of age, over 15 years will be needed to achieve a 15 year replacement cycle if only Act 271 funding is received. Additional non-recurring funding is needed annually to expedite placing all firefighters in safer enclosed environmental cabs within five years. Due to many years of receiving little or no equipment replacement funding, at the end of this five year period, with only Act 271 funding, the agency will still need to replace approximately 80 units with over 60 being between 16 and 22 years old.
