## **EB-5 IMMIGRANT INVESTOR PILOT PROGRAM**

### **TARGETED EMPLOYMENT AREAS**

#### **FOR THE STATE OF SOUTH CAROLINA**

The South Carolina Department of Commerce is the designated agency in South Carolina responsible for defining Targeted Employment Areas for the purposes of investment qualification as part of the EB-5 Immigrant Investor Pilot Program (8 C.F.R. §204.6).

Guidelines for defining Targeted Employment Areas are provided in the EB-5 Immigrant Investor Pilot Program (8 C.F.R. § 204.6). The Department of Commerce will follow guidelines pursuant to 8 C.F.R. § 204.6 in defining qualifying Targeted Employment Areas. The following types of areas qualify as Targeted Employment Areas under this program:

- **Rural Area** - any area not within either a metropolitan statistical area (as designated by the Office of Management and Budget) or the outer boundary of any city or town having a population of 20,000 or more.
- **High Unemployment Area** - an area that has experienced unemployment of at least 150 percent of the national average.

All geographical areas defined as Targeted Employment Areas are eligible for the reduced investment amount designated in the EB-5 Immigrant Investor Pilot Program (8 C.F.R. § 204.6).

Areas in South Carolina that qualify as Targeted Employment Areas for the EB-5 Immigrant Investor Pilot Program (8 C.F.R. § 204.6) based on one or both of the definitions above are identified in Exhibit A.

If the location of a proposed investment does not fall into one of the qualifying areas listed in Exhibit A, justification for a high unemployment area may be possible by special designation of a smaller area within an otherwise non-qualifying area. The process for requesting exceptions to the Targeted Employment Areas listed in Exhibit A is described in Exhibit B.

**EXHIBIT A: Targeted Employment Areas in South Carolina, 2013**

The following table provides the South Carolina census tracts that qualify as Targeted Employment Areas (TEAs), using 2012 annual average unemployment figures.

Calculations of unemployment rates for counties and census tracts were made using 2012 annual data from the U.S. Department of Labor, Bureau of Labor Statistics. County unemployment rate data comes directly from the Bureau of Labor Statistics. Census tract unemployment estimates are calculated using the census-share method, which applies each tract’s share of total employment and unemployment from the most recent census survey in order to disaggregate county employment and unemployment figures from more timely Bureau of Labor Statistics data. The census tract share of county employment and unemployment is estimated using data from the US Census Bureau, American Community Survey Five Year Estimates (2007-2011). This is the most recent data that provides sufficient precision for the census share method.

## **EXHIBIT B: Targeted Employment Area (TEA) Exception Requests**

If the location of a proposed investment does not fall into one of the qualifying areas listed in Exhibit A, justification for a high unemployment area may be possible by special designation of a smaller area within an otherwise non-qualifying area. The South Carolina Department of Commerce may designate a particular geographic or political subdivision located within a metropolitan statistical area as an area of high unemployment and having at least 150 percent of the national average rate.

Applicants for special TEA designations must observe the following criteria:

- A) The proposed TEA designations should include a description of the boundaries of the applicable geographic or political subdivision as described below:
  - a. Geographic Subdivision: an area delineated by physical features of the Earth's surface.
  - b. Political Subdivision: a division of a state that exists primarily to discharge some function of local government, such as a civil administration unit of a county or city.
  
- B) The proposed TEA must have an annual average unemployment rate, using the latest data available, equal to or exceeding 150 percent of the national unemployment rate during the same period. The unemployment rate for the proposed area must be calculated using the weighted average of the unemployment rates of the contiguous census tracts which most closely approximate the desired area. The census tract unemployment rates should be calculated using the census-share methodology using the latest data available from the US Census Bureau and Bureau of Labor Statistics.

To support the evaluation of the proposed investment project, applicants seeking special TEA designations should also provide a logical economic reasoning, one that would be recognized within the investment area for the specific business or industry, for why the proposed area should be designated as a TEA. Such reasoning should include any and all information necessary to justify the claim that establishment of the investment project will have a positive, meaningful and lasting effect on unemployment in the proposed TEA.
