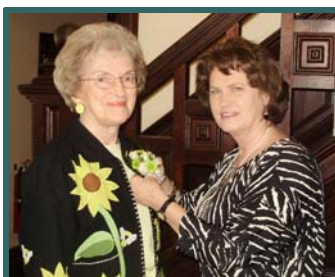

FOSTER CARE REVIEW NEWS AND VIEWS: PACKET-LIGHT PROJECT

The Foster Care Review Board (FCRB) and the Department of Social Services (DSS) have embarked on an exciting new pilot project. The goal of the Packet-Light Pilot Project is to determine if quality foster care reviews can be conducted without the transmission of large volumes of documents. The impetus for the project was the reality of budget cuts, which have resulted in limited staff and resources for the FCRB and DSS.

At the core of the pilot project is an enhanced DSS Form 1597 (Summary Sheet). When completed correctly, this enhanced form provides additional information preventing the need for submitting copies of letters of invitation, case plans, progress reports, and most court pleadings. Certain documents, such as court orders, complaints for removal, psychological evaluations, reports from Adoptions, and relative home studies, will continue to be submitted for consideration.

The pilot project has been implemented with three local review boards, four counties and the respective Adoptions and Intensive Foster Care and Clinical Services Offices. The participating counties are Calhoun, Orangeburg (Review Board 1A), York and Union (Review Boards 16A and 16B).

The pilot was implemented in August. After three months, the pilot will be assessed by surveying participating review board members, review board coordinators, and DSS caseworkers and supervisors. The survey results will determine if this initiative should be replicated in other counties. Stay tuned for outcomes of the Packet-Light Project.

FOSTER FACTS: 2009—2010 ANNUAL REPORTS

Each year about this time, the Review Board is busy collecting, editing, and analyzing data for annual reporting. In addition to the Annual Report prepared for the Review Board State Board of Directors and submitted to the Governor and General Assembly, we also produce an annual Accountability Report and Activity Report. The 2009—2010 Annual Report has been distributed and is available on our website at <http://oepp.sc.gov/fcrb>.

The Review Board portion of the annual Accountability Report has been completed. The Accountability Report is, based on Malcolm Baldrige criteria of 1) Leadership, 2) Strategic Planning, 3) Customer Focus, 4) Measurement, Analysis and Knowledge Management, 5) Human Resource, 6) Process Management, and 7) Business Results. The Accountability Report summarizes the agency's performance for the previous fiscal year, and is submitted annually to the Governor and the General Assembly for review.

The FCRB portion of the Activity Report has also been completed. The Office of State Budget, in conjunction with the Governor's Office, updates the Agency Activity Inventory annually to assist in development of the Governor's Executive Budget.

RECORD BREAKING ADOPTION DAY IN SUMTER

On Wednesday, June 2, 2010, The Honorable George M. McFaddin, Jr., held a special Family Court day to finalize thirty-three adoptions for families. Judge McFaddin began holding "adoption days" a couple of years ago as a result of meeting with local review board members from Lee and Sumter counties. Judge McFaddin set aside an entire Family Court day so these children and families could realize their dream of being "forever families".

I joined the South Carolina Heart Gallery as Program Assistant in March, and the six months that have passed since that time have been quite an adventure. After seeing the job posted on the South Carolina State Government website, I wondered "What is the Heart Gallery?" It sounded like something medical, but it was part of the Children's Foster Care Review Board. Having a background in social services, I was intrigued and went online to investigate. From the first moment I viewed the children's portraits on the website, I was hooked. Looking at the beautiful faces of the children who are waiting for their "forever family" is mesmerizing. I found myself wondering if this child or perhaps that child would fit into my own family. What would my son think about having a sibling? As an only child he used to long for a sibling, but now at 12, I wondered if he would still feel the same enthusiasm. But wait, I'm preparing for a job interview, not trying to adopt a child! So I sent my application in and hoped to be called for an interview.

When I received the call, I was ecstatic. I reviewed my work history, my goals, and the skills that I knew I could bring to this position. I wondered how could I convey that this job appeals to me not only professionally, but also personally? Would it be appropriate to say in the interview that I am adopted, and have two adopted brothers, or would that be unprofessional? When my interview finally arrived, I decided to mention at the end that I am adopted and felt a special connection to this type of work.

Fortunately for me, I was offered the job and happily accepted! And since March 2nd I have had the privilege of trying to make a difference in the lives children in foster care who are legally free for adoption. I have met the children at photo shoots, seen the hope in their eyes, felt their excitement (and sometimes reluctance) at being photographed. I have interviewed them for the biographical information we include on the website and heard their hopes and dreams and aspirations. I have met the photographers who donate their time and talents to make these amazing photographs. I have seen the generosity of local review board members, who in addition to volunteering their time to review cases, also donate snacks, drinks and their time for the photo shoots. I communicate with prospective adoptive families every day, through email or telephone, and put them together with the hard working DSS Adoption Specialists who have dedicated their careers to help children in foster care find permanent homes and families

We all have big dreams for the Heart Gallery children. As we reach out through our website, photo exhibits, open houses and media exposure to the families of South Carolina - to families all over the country - I believe we can all make their dreams of a "forever family" a reality. LEGAL LINES: LEGISLATIVE UPDATE

The 118th Legislative Session, which ended in June, proved to be a very positive one for policy change on behalf of South Carolina’s children and families involved in the foster care system. The most significant pieces of legislation enacted were:

South Carolina Education Bill of Rights for Children in Foster Care (South Carolina Code Annotated Section 59-38-10, Senate Bill 1134) This bill, sponsored by Senators Peeler and Ford, requires school districts to have procedures in place to ensure seamless transitions between schools and school districts for children in foster care. The new law requires the school districts to immediately enroll children who are in foster care, establishes a two-day time frame for a school to request records for a child who transfers in and a two-day time frame to

transfer student records to a new school or district. The law also requires the child stay in the same school if at all possible and ensures that if a child misses school due to a certified court appearance or related court-ordered activity, the absence is excused and the child shall be allowed to make-up all assignments and required seat time.

Early permanency (Senate Bill 1172) This bill strengthens existing law by expediting children’s cases when the child has entered foster care due to aggravated circumstances such as torture, abandonment, sexual abuse, and severe abuse and neglect. The new law also requires birth parents to exercise due diligence in completing their treatment objectives within a year of his/her child entering care if the expectation is to have the child returned home

within 18 months of entry into care. The law also simplifies the statutory language regarding placement plans.

Adoption protections (also Senate Bill 1172) The new law prohibits non-licensed entities from advertising adoption services within the State and requires that the adoption of a South Carolina child must be initiated and finalized in South Carolina, unless it is step-parent or family adoption.

Senate Bill 1172 was a very comprehensive piece legislation that made it through the legislative process very quickly thanks to leadership from Senator Fair and Representative Brady who both serve on the Joint Citizens and Legislative Committee on Children, as well as several other members of the Senate and House who supported this bill.
