# THE YEAR IN REVIEW

The South Carolina Workers' Compensation Commission is proud to report its activities and accomplishments for Fiscal Year ending June 30, 2012. Through the efforts of its 54 dedicated employees, the Commission continues to focus on accomplishing its mission to provide an equitable and timely system of benefits to injured workers and employers in the most responsive, accurate, and reliable manner possible. The Commission continues to improve the efficiency of operations, focus on transparency, fairness, consistency and engaging all stakeholders in the development and implementation of fee schedules, regulation changes, and changes in policies and procedures.

#### **Financial Condition**

- State appropriations to the Commission have been reduced during the past three fiscal years, necessitating the implementation of a series of expenditure reductions and reliance on cash reserves. The Commission's total budget for FY 2012 was \$5 million, \$1.7 million in General Funds and \$3.3 million in Other Funds. The fiscal year closed with total expenditures of \$4.8 million for a \$210,000 reduction in actual versus budgeted expenses.
- Even though the Commission implemented measures to reduce expenses, it was necessary to utilize \$600,000 in fund balance.
- The Commission has initiated a project to identify sustainable future revenue sources and expenditure reductions through efficiency measures.

# Key Accomplishments

- A new Pharmacy Fee Schedule was adopted that requires all bills for repackaged medications to include the original manufacturer's NDC and that the maximum allowable reimbursement shall be calculated by multiplying the number of units dispensed by the per unit average wholesale price set by the original manufacturer for that medication.
- Approved a five-year Memorandum of Agreement with the SC Vocational Rehabilitation Department for referring industrially injured persons for vocational counseling or evaluation, personal adjustment, training and placement.
- Approved the final language for the proposed change to Regulation 67-706 Oral Argument. The amended regulation requires parties to arrive at the hearing site for appellate panel 30 minutes prior to the scheduled time of the hearing. The proposed regulation will be considered by the General Assembly in 2013.
- Regulations were approved and submitted to the General Assembly requiring mediation of certain cases prior to a hearing with a Commissioner. The proposed regulations will be considered by the General Assembly in 2013.

# THE YEAR IN REVIEW—cont.

#### Communication/External Relations

- Conducted three training sessions, Claims Administration Workshop Made Easy, for 157 stakeholders in October 2011 and May 2012. Attendees included Attorney's, Insurance Companies, TPA's, Employers and others who deal with claims.
- Posted all agendas for the Commission Business Meetings on the Commission's website two days prior to the meetings.
- Added 138 contacts to the Commission's general notice distribution list.
- Posted 97 general notices to the Commission's website
- Emailed 51 general notices, policy advisories and updates to stakeholders and other interested parties.
- Appointed an ad hoc committee for the purposes of drafting a regulation dealing with mediations for workers' compensation system.
- Appointed an ad hoc committee of stakeholders to review the current and alternative methodologies used to calculate net present value of lump sum payments to ensure fairness to the claimants and the employers.
- Commissioner Gene McCaskill was appointed to the Commission by Governor Nikki Haley to fill an unexpired Commission seat. Commissioner McCaskill served January 3 through June 30, 2012. Governor Haley appointed him to a six-year term which commenced on July 1, 2012 and expires on June 30, 2018.
- Commissioner Melody L. James was appointed to the Commission by Governor Nikki Haley to fill an expired Commission seat. Commissioner James' term commenced on April 25, 2012 and expires June 30, 2016.

# Compliance

Decreased Compliance investigations by 45.5% (1,690 to 921).

# Claims

- Number of cases filed with the Commission decreased 5,566, or 8%, (67,354 to 61,788) from the previous fiscal year.
- Processed 12,613 settlements (Clinchers, Form 16s, and third party settlements) and 27,610 initial notices of payments.

#### Hearings

- Assigned 4,706 cases for Informal Conferences. (FY11 assigned 5,307)
- Conducted 3,262 Informal Conferences. (FY11 conducted 3,758)
- Docketed 11,121 cases for single commissioner hearing. (FY11 docketed 9,644)
- Cases docketed for single commissioner hearings increased 1,477 or 15% although hearings conducted by a commissioner decreased 230 or 11%.
- The number of settlements increased by 423 or 4%.
- Single commissioner cases appealed to the Full Commission decreased by 47 or 8%.
- The number of cases reviewed by the Full Commission decreased by 39 or 13% and the number of Full Commission cases appealed to higher court increased by 11 or 7%.

#### **Appeals**

- Processed 560 appeals to the Full Commission. (FY11 processed 607)
- Conducted 264 appellate hearings. (FY11 conducted 303)
- Full Commission decisions appealed to higher Court-168. (FY11—157 appealed)
