Description of Project: A Feb., 2015 report by Schnabel Engineering documented that the principal spillway intake structure and conduit, consisting of Corrugated Metal Pipe (CMP), had exceeded their design life and that uncontrolled seepage was observed on the downstream slope of the dam. The analyses indicated that the existing dam and associated spillway system are not capable of safely storing and/or passing the runoff associated with the design storm without overtopping the embankment. Given that the existing principal spillway system is in poor condition, the report recommends that either a pipe and riser or siphon spillway be constructed and the existing spillway be removed from service. The report also recommended that an internal drainage system be installed to collect the documented seepage and the downstream slope be flattened to facilitate maintenance and improve stability. The DHEC Dams and Safety Program Division agrees with the report's recommendations. The dam is classified as a High Hazard (Class I) dam due to the proximity of residences to the spillway.

Description of Professional Services Anticipated for Project: SCOPE OF SERVICES: Design remedial measures to bring the dam into general compliance with the requirements as established by SC DHEC in the current version of the Dams and Reservoir Safety Act Regulations. The work will include:

- Survey work, subsurface exploration and soils testing to support the design
- Design of spillway system and internal drainage system

- Preparation of construction plans, technical specifications and design report
- Construction observation and materials testing

Design a spillway system that is capable of safely storing and/or discharging runoff from the SC DHEC required design storm event. Prepare construction plans and technical specifications suitable for submission to SC DHEC for review and approval. During construction, provide construction administration services to include; observation of site conditions with respect to design assumptions and observation of construction activities with respect to the construction documents.
