**SUBJECT: Exemption to the waiting list for Community Long Term Care (CLTC)
Community Choices waiver**

Effective immediately, Medicaid eligible hospital patients who no longer require acute care and are seeking long term care may exempt the waiting list for Community Choices. An assessment and level of care must be made by CLTC prior to the patient's discharge. Referrals must be made to the appropriate CLTC office.
