**New Travel Guide to SC African American Cultural Sites**

Check out [The Green Book of South Carolina](#), the first mobile travel guide to African American cultural sites across South Carolina. Created by the SC African American Heritage Commission, it provides a user-friendly guide to cultural experiences across the state, and includes tourism sites and attractions from every county. The guide showcases more than 300 attractions and sites, allowing travelers to plan customized itineraries by quickly searching through categories such as historic districts, historical markers, churches, and more to find the attractions. With an interface similar to that of a tourism app, this free mobile-first, web-based guide features detailed listings with descriptions, images, categories and map points, designed with the mobile smartphone or tablet user in mind. ### **2017 South Carolina Hall of Fame Inductees**

On May 5, 2017, the SC Hall of Fame added two new members during a ceremony at Winthrop University. **Stanley Donen**, an American film director and choreographer, was honored as the 2017 contemporary inductee. Born in Columbia in 1924, his most famous work is *Singin' In The Rain* (1952) which he co-directed with Gene Kelly. Mr. Donen was nominated for five Directors Guild of America Awards, and in 1998 received an honorary Academy Award "in appreciation of a body of work marked by grace, elegance, wit, and visual innovation." **David Bancroft Johnson**, founder and first president of Winthrop University (1886-1928), was honored as the posthumous inductee. ### **FY2017 Federal Historic Preservation Funding**

As reported by Preservation Action, the FY17 Omnibus spending bill recently approved by the House and Senate and signed by President Trump included positive funding news for preservation. The bill included appropriations for the Save America's Treasures program, which supports the preservation of nationally significant sites, structures and artifacts, increased the civil rights competitive grants program, which supports sites associated with the Civil Rights Movement, and funding for the

Historically Black Colleges and Universities (HBCU) preservation program. Specific amounts are below:

- State Historic Preservation Offices: \$47.925 million
- Tribal Historic Preservation Offices: \$10.485 million
- Civil Rights Movement Grants: \$13 million
- Underrepresented Communities Grants: \$500,000
- Save America's Treasures: \$5 million
- HBCU Preservation Program: \$4 million

The bill also included level funding of \$19.8 million for the Heritage Partnership Program for National Heritage Areas, and \$10 million for the American Battlefield Protection Program.

**June 1, 2017 National Trust Preservation Funds:** Grants from the National Trust Preservation Funds are intended to encourage preservation at the local level by providing seed money for preservation projects. These grants help stimulate public discussion, enable local groups to gain the technical expertise needed for particular projects, introduce the public to preservation concepts and techniques, and encourage financial participation by the private sector.
