## MEDICAID BULLETIN

**TO: Service Coordinators and Providers who Render Individuals with Disabilities Education Act (IDEA) Part C Services**  
**SUBJECT: Changes to Applied Behavioral Analysis Provider Credentialing Requirements**

As part of the ongoing effort to improve the quality and delivery of services for infants and toddlers with disabilities and payment process to providers through the Individuals with Disabilities Education Act (IDEA) Part C program, commonly known as “BabyNet,” the South Carolina Department of Health and Human Services (SCDHHS) is integrating IDEA Part C and Healthy Connections Medicaid policies. SCDHHS is informing the provider and beneficiary community about all actions necessary to implement this realignment through a series of alerts and bulletins. This bulletin announces changes to credentialing requirements for IDEA Part C providers who render Applied Behavioral Analysis (ABA) therapy pursuant to an approved Individualized Family Service Plan (IFSP).

Effective Oct. 1, 2019, ABA providers within the IDEA Part C network, including supervisory and direct therapy providers, must meet the provider qualifications specified in the Autism Spectrum Disorder (ASD) Medicaid State Plan, which is [available on SCDHHS’ website](#). Requiring ABA providers to credential with the Behavioral Analyst Certification Board (BACB) aligns IDEA Part C provider qualifications with Healthy Connections Medicaid qualifications and current industry standards. Families electing to receive services from non-credentialed providers may continue to do so; however, SCDHHS will no longer reimburse for them for dates of service after and including Oct. 1, 2019.

If an ABA provider employs non-credentialed staff, they must contact service coordinators to make sure children who are covered by Healthy Connections Medicaid, including IDEA Part C, are receiving services from appropriately credentialed staff. Service coordinators serving children who need to transition to a different provider should contact Gail Shelley at [Joyce.Shelley@scdhhs.gov](mailto:Joyce.Shelley@scdhhs.gov) to begin transitioning the child to a provider who meets the credentialing standards.

**Provider Qualification Table**

CREDENTIAL	PROVIDER QUALIFICATIONS
Board Certified Behavior Analyst-Doctorate (BCBA-D)	BCBA-D is the doctoral designation for a Board Certified Behavior Analyst (BCBA) with doctoral training in behavior analysis. BCBA-Ds supervise the work of Board Certified Assistant Behavior Analysts (BCaBA), Registered Behavior Technicians (RBT) and others who implement behavior-analytic interventions.
BCBA	A BCBA has a graduate-level certification in behavior analysis. BCBA-Ds supervise the work of BCaBAs, RBTs and others who implement behavior-analytic interventions.
BCaBA	A BCaBA has an undergraduate-level certification in behavior analysis. BCaBAs must be supervised by someone certified at the BCBA-D or BCBA level. BCaBAs can supervise the work of RBTs and others who implement behavior-analytic interventions.
RBT	A RBT is a paraprofessional who practices under the supervision of a BCBA-D, BCBA or BCaBA. The RBT is primarily responsible for the direct implementation of behavior-analytic services. The individual supervising the RBT is responsible for the work performed by the RBT. An RBT must be 18 years of age or older, possess a minimum of a high school diploma or national equivalent, complete 40 hours of training, pass the RBT Competency Assessment and pass the RBT exam.

In addition to the changes in the provider qualifications, SCDHHS has also aligned all BabyNet services to ASD services currently covered in Medicaid. Please see the table below for a comparison.
