# Governor Appoints New Board Member

Eight of the nine positions on the South Carolina State Board of Nursing are now filled. On October 20, 2000, Governor Jim Hodges appointed James P. Rogers, Esquire, to the Board. Rogers serves as our public member. His term expires December 31, 2005. Rogers is a 1977 graduate of Howard University in Washington, D.C. and was admitted to the South Carolina Bar that same year. He is an attorney in Columbia, and attended his first Board meeting in November. The Board looks forward to working with and welcomes Rogers aboard.

# **Don't Forget to Renew**

Renewal applications will be mailed before October 1, 2001, pursuant to state law. Please mark your calendar now. If you do not receive your renewal application by October 31, 2001, contact the Board at (803) 896-4550 to receive a duplicate. Renewal applications are mailed out at the end of September. Your license must be renewed annually by January 31<sup>st</sup>. We encourage you to renew early to avoid the rush and stress at the end of renewals in January.

Our online renewal pilot project was a success. Online renewal will be offered to all licensees in the upcoming renewal period. Instructions along with your personal identification number (PIN) will be included with your renewal application. We hope this will make renewing your license easier.

# **Check Out Changes to the Web Site**

We are updating and enhancing our Web site. Our Web address is www.llr.state.sc.us/pol/nursing. This site contains information on Board-approved nursing education programs, examinations and endorsement for initial licensing in the state. There is information on official recognition and prescriptive authority. We recently added downloadable applications for official recognition and prescriptive authority and hope to have all applications available in the future. Disciplinary actions are posted on the site after Board decisions are final. Also included on our website are advisory opinions, frequently asked questions, Board/committee meetings calendars, links to other Web sites, and other valuable information. # Board Approves Two New Advisory Opinions

During the January 2001, Board meeting, two new advisory opinions were approved. Advisory Opinion #35 describes the role of the LPN to perform additional acts and replaces an earlier statement of the Board entitled "Advisory Opinion Attachment: Additional Acts for the Licensed Practical Nurse." The Board also approved Advisory Opinion #36 which describes the role of the LPN to practice without on-site RN supervision. Advisory Opinion #36 replaces the 1998 statement published in the South Carolina State Register. # School Health Nursing Task Beginning Work

The Board of Nursing and Nursing Practice and Standards Committee are collaborating to form the School Health and Nursing Task Force. The Task Force will collect information and data on school health nursing in South Carolina and bring to light issues in school nursing which are impacting the health of students and posing difficult practice questions for licensed nurses. The members of the Task Force welcome information, data and testimo-



nies of health concerns in the schools, as well as participation from interested nurses. Mainstreaming of students with special health needs into schools without nurses is an especially urgent concern. # **Board Appoints Advanced Practice Subcommittee Members**

The first six members of the Advanced Practice Subcommittee to the Nursing Practice and Standards Committee were appointed by the Board in January. The new members are Sharon Bond, CNM, Pat Abercrombie, CRNA, Lynn Albert, CNM, Rodel Bobadilla, FNP, Claudia Rogers, CRNA and Kathy Saunders, PNP. It is expected that the remaining four membership vacancies will be appointed by the Board of Nursing during its March meeting. The subcommittee will advise the full committee and Board on advanced practice guidelines and scope of practice. Advanced practice questions and concerns may be submitted in writing to Bob Barnwell, who will refer them to the subcommittee for its review and recommendations.

# Multiple Specialty Recognition of Advanced Practice Nurses Gets Approval

The Board has approved granting Official Recognition and Prescriptive Authority to advanced practice nurses who meet all of the qualifications for more than one specialty practice area. Advanced practice nurses who meet educational and national certification requirements in more than one specialty area may apply for recognition in each area. A separate application and fee are required for each recognition and prescriptive authority desired. This change will enable advanced practice nurses to work in their different specialties in varying settings for which they are fully qualified. # LLR Maps Out Its Strategic Plan

When the South Carolina legislature created the Department of Labor, Licensing and Regulation (LLR) in 1994, one driving goal was to improve efficiency and the quality of service delivered by the 40 separate agencies that were merged to form the agency.

The legislature envisioned an agency that would promote efficiency and build accountability. With that in mind, LLR's staff has created a strategic plan for the agency. This plan is a roadmap to help the agency reach the ultimate goal of being the best state government agency in the United States by the year 2010.

- Key points of the strategic plan include:
- Core purpose or mission Making South Carolina a Better and Safer Place to Work and Live.

- Core values Provide excellent service, act with integrity and treat people with respect.
- Key strategies "Maximize Customer Satisfaction," "Maximize Employee Satisfaction" and "Use Resources Efficiently."

Several interim goals also were established:

- By 2001, be recognized in the Southeastern United States as a leading state government agency.
- By 2002, be recognized in the United States as a leading state government agency.
- By 2005, have specific performance measures in place to track progress toward being the best state government agency in the United States.

"These interim goals will keep us focused on the larger goal of being the best state government agency in the United States by 2010," LLR Director Rita M. McKinney said. "I like to think of these goals as short-term wins on the road to achieving excellence in public service."
