Are You Breaking the Law?

It has been brought to the attention of the S.C. Board of Cosmetology that a few licensed massage therapists are operating under the misconception that they are also licensed to perform skin care.

If you are a salon owner, please be sure your massage therapists are working within their scope of practice or licensure.

Discussions were entered into by Pat Adams, chairman of the Cosmetology Board, and Carolyn Talley, a Massage/Bodywork Therapy Panel member. Both have agreed that no one should perform services outside the scope of their license. Communications between Adams and Talley are ongoing in an effort to resolve this matter.

National News

Echo Morris, board member, has been named national chairman for the NIC Nail Manufacturers Council. Morris will also serve on a panel for ethics and state government for Region Five. Pat Adams, chairman, has been appointed to a panel for continuing education for Region Five. Region Five will hold a meeting in Biloxi, Miss. April 7 - 9. The S.C. Board of Cosmetology will serve as registrants for that meeting.

CHANGE!!! A word that we must all embrace with open minds. Change is everywhere, and it doesn't exclude our industry. The Board of Cosmetology has met the challenges of change with open arms because without change, our industry will be at a stand still, and this board will not allow that to happen.

There have been many changes the past few years that are very positive and have helped move this industry into the 21st century. A few are: the addition of booth renter licensure; requiring anyone taking the exam to be able to read, write and speak English; subcontracting the practical exam to Cosmetology Testing Provider (CTP) of Columbia; and licensing onsite anyone successfully completing the exam. All schools, both private and public, are now licensed by the Board of Cosmetology, and starting this year we will be issuing biennial (two year) licenses. As you can see, change has been good for the industry. Individual licenses and schools that comply with the statutes and regulations of the State of South Carolina will always have the Board's support and will be treated equally.

On a final note, please help the board welcome our new member, Delores Gilmer, of Charleston. She will fill the consumer seat.

Remember, if you do not receive a renewal notice by the end of January and you have completed your required CEU credits, contact the board office.

Cosmetology Salon Inspections

The goal of LLR and the Board of Cosmetology is to perform annual inspections of all cosmetology salons to ensure the safety and welfare of the consuming public. When an inspector arrives in your salon he or she should present their business card to the manager, and if requested, present their LLR photo identification card. If you are not familiar with the inspector, you should ask for identification before you allow them access to all areas of your salon. The inspector should then perform a thorough inspection in a professional and courteous manner. After completing the inspection, the inspector should present the inspection report to the manager. If there are problem areas, the problems and recommended solutions will be discussed with the manager. Microdermabrasion and the Esthetician

As the new millennium gets under way, there are many new and exciting treatments being made available to our clients. Many of these treatments are providing miraculous results in the improvement of skin resurfacing and texture. A few of the benefits include improvement of fine lines and wrinkles and superficial pigmentation with a healthy looking glow.

One of the most exciting treatments we are seeing is the introduction of microdermabrasion - a fine mist of microscopic aluminum oxide crystals to exfoliate the top layers of the skin. Think of a sandblaster followed by a vacuum cleaner. This can prove to be a powerful tool in the esthetician's hands.

Unfortunately, this machine can also produce damaging results if not used properly. This is the reason the medical

community would love to see this machine restricted from our use. Qualified estheticians should not permit this to happen, but we can only do this by being sure that anyone in possession of this equipment has achieved extensive training in its use and functions. This treatment is a great asset to our treatment menu, but we must demand proper training. A great source of additional information and training is a guide written by Laura L. Root; CIDESCO Diplomate titled "A Complete Guide to Microdermabrasion-Treatment, Technique & Technology." This is the only non-manufacturer sponsored training manual for microdermabrasion, including treatment protocols, charts and consent forms. Renewal Changes on the Way

The Board of Cosmetology, on a regular basis, is looking for less taxing and more efficient ways to serve its licensees.

This past Legislative year, the Legislature voted and ratified bill #493, which empowered the board to institute and enforce biennial licensing, meaning, we will soon be renewing our licenses every two years rather than every year.

In January 2001, license renewal notices will be mailed to all licensees who have met their continuing education requirements for this year. The license will be in effect March 10, 2001, to March 10, 2003.

During the two-year period the licensee is required to attend two continuing education classes or 12 hours of instruction. The continuing education instruction may be taken in one year if so desired. By December 31, 2002, the licensee must have completed 12 hours of instruction.

If all continuing education has been received by December 31, 2002, the licensee will again pay a \$30 fee and renew for two years in 2003.

For those individuals who do not receive their continuing education by December 31, 2000, the current late fee of

\$50 will be applied. Beginning in 2001, the late fee for a two-year license will be \$75.

Anyone entering the profession will pay the license fee, and that license will be valid until March 10, 2003.

The instructor's license will follow the same procedure as above.

The license fee for the instructor is \$60 for a biennial license. Between January 1, 2001, and December 31, 2002, the instructor must receive 30 hours of continuing education. Renewal notices for those individuals who have received the 30 hours of continuing education will be mailed in January 2003.

Beginning in 2002, all salon owners, booth renters and schools will begin the biennial license process. These licenses will renew on the even years (2004, 2006, etc.). The fee will be \$50, and the license will be valid from June 30, 2002, to June 30, 2004.

It is the board's desire that this process be understood by you, as licensees, so the transition into biennial licensing will be an easy process. All biennial license information will be discussed during the upcoming continuing education classes.
