## Why Sanitation is a Must!

Recently in Watsonville, Calif., there has been a never before seen outbreak of chronic skin lesions that is non-reactive to standard antibiotic therapy. One hundred and five cases have met the furunculosis case definition. Of these 105, 28 are culture-confirmed as *M.fortuitum*, four are acid-fast-positive rapid growers not yet identified, and seven cultures have been negative for rapidly growing *Mycobacteria*.

The only common link between these 105 people are the location of spa pedicures. The Health Services Agency ordered the owner to close the pedicure operations of the business after new reports of hand and arm lesions. None of these have been confirmed as *M.fortuitum*.

At the time the salon was inspected, all of the inlet screens and inlet pipes behind the screens of the footspas were grossly contaminated with debris. Swabs of the debris were taken for culture: smears were loaded with acid-fast bacteria, cultures yielded *M.fortuitum*. Two of the isolates of *M.fortuitum* from skin lesions of patients match each other and also match the isolate from one of the footspas.

The footspas and inlet pipes behind the screens were cleaned by the owner and a bleach-hot water solution of unknown concentration was circulated through the systems for several hours,

### Renewals

Question: If your driver's license expires, whose responsibility is it to make sure it is renewed?

Answer: Yours. If you are caught driving with an expired license, you will be fined.

Question: If your professional license expires, whose responsibility is it to renew that license?

Answer: Yours. If you are caught working on an expired license, you will be fined.

It is your responsibility to renew. It is not the responsibility of LLR or the Board of Cosmetology. People will renew their driver's license, but want to put the responsibility on someone else when it comes to renewing their professional license, which is their livelihood.

Please remember to renew on time. It just makes sense.

### Reminder

If there are any cosmetologists performing massage to their clients, please be aware that you must have a massage therapist license. Your cosmetology license **does not** cover this service.

## Make Sure You are Working in a Properly Licensed Salon

As a reminder, anyone working with a cosmetologist, esthetician or nail tech license should make sure they are working in a properly licensed salon. Recently, an esthetician/massage therapist discovered she was in violation of this law and brought it to our attention. All licensees, except those working in a doctor's office, must be working under a salon license.

We are sorry for any misunderstanding this has caused.

# Written Requests a Must for Inactive Status

All persons holding a current license - cosmetologists, nail technicians, estheticians or instructors - who want to place their current licenses on **inactive** status must do so in writing. Telephone requests will not be accepted. The written request to place your current license(s) on inactive status should be addressed to Eddie Jones, Board administrator. Documents needed to place a license on inactive status are: a copy of your license(s), a change of address if not the same as the license and applicable fees. **Keep a copy of the letter for your records.** The fee must be sent in each year. No notice will be mailed to an inactive licensee.

Regulation #35-23 Continuing Education Requirements. Section G covers inactive licenses and reinstating licenses.

A license can be placed on inactive status for three to five years. However:

1. A person holding an inactive license who wishes to activate the license must make application to the Board with payment of the required license fee at the time of application and proof of CEU requirements for the coming year.
2. After three years and up to five years of the expiration date of an inactive license, the license is no longer renewable by payment of fees. The applicant must repeat and pass the practical phase of the examination. Then, the inactive licensee will be considered on the basis as a newly licensed individual.
3. After five years, the full examination must be repeated (practical and written). The licensee will be considered on the same basis as a newly licensed individual.

## National Board Meeting Held in Mississippi

The National Interstate Council of State Boards of Cosmetology, Inc. held its Region V meeting April 5, 8 and 9<sup>th</sup> in Biloxi, Miss. David Bagwell, board member and Region V Director, of Hilton Head Island, made all the arrangements for the meeting.

The Mississippi State Board hosted the Saturday welcome reception. Sunday morning's opening session began with registration and roll call of the states. A total of 10 states and 33 delegates were in attendance.

Larry Walthers, national president of the National Interstate Council of State Boards of Cosmetology, Inc., gave a very warm welcome to everyone. The agenda started with Bagwell defining parliamentary procedures.

Peggy Moon, NIC testing rater director, and Aurie Gosnell, coordinator of testing program, emphasized the importance of keeping the NIC testing program current with textbooks in use at this time, and also the importance of a correctly formed question.

Patricia Adams, Chairman, South Carolina Board of Cosmetology, spoke on the history of continuing education units in South Carolina.

There was a discussion of the pros and cons of merging beauty and barber boards. One subject of interest to all board members was "How Does a Standardized Curriculum Effect Credit Hours or Clock Hours."

# LLR Maps Out Its Strategic Plan

When the South Carolina legislature created the Department of Labor, Licensing and Regulation (LLR) in 1994, one driving goal was to improve efficiency and the quality of service delivered by the 40 separate agencies that were merged to form the agency.

The legislature envisioned an agency that would promote efficiency and build accountability. With that in mind, LLR's staff has created a strategic plan for the agency. This plan is a roadmap to help the agency reach the ultimate goal of being the best state government agency in the United States by the year 2010.

Key points of the strategic plan include:

- Core purpose or mission – Making South Carolina a Better and Safer Place to Work and Live.
- Core values – Provide excellent service, act with integrity and treat people with respect.
- Key strategies – “Maximize Customer Satisfaction,” “Maximize Employee

Satisfaction” and “Use Resources Efficiently.”

Several interim goals also were established:

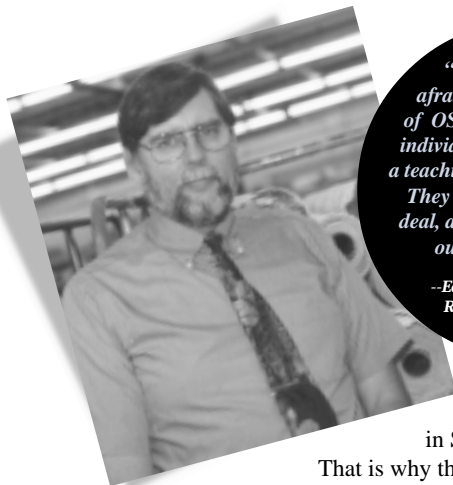
- By 2001, be recognized in the Southeastern United States as a leading state government agency.
- By 2002, be recognized in the United States as a leading state government agency.
- By 2005, have specific performance measures in place to track progress toward being the best state government agency in the United States.

“These interim goals will keep us focused on the larger goal of being the best state government agency in the United States by 2010,” LLR Director Rita M. McKinney said. “I like to think of these goals as short-term wins on the road to achieving excellence in public service.”

## Don't Forget ...

- 2001 licenses expire March 10, 2003.
- All cosmetologists, nail technicians and estheticians must complete 12 hours of continuing education by Dec. 31, 2002. After meeting this requirement, the renewal fee will be \$30 on or before March 10 and \$80 after March 10.
- All instructors must complete 30 hours of continuing education by December 31, 2002. After meeting this requirement, the renewal fee will be \$60 on or before March 10 and \$110 after March 10.
- If your continuing education class is taken after December 31, 2002, (in preparation for the 2003 renewal period) add a late fee of \$50 to the above fees.
- If you did not hold a license from the previous year, you will be required to pay the maximum fee with continuing education credit as the prerequisite.

let set over night, then flushed with clear water the next day. Subsequent cultures still yielded scant growth of *M. fortuitum* from the inlet pipes of several footspas. Yes, this was in California, but it could just as easily happen in your salon if you are not taking the proper steps to properly clean your footspas, along with all of your implements. If you own a footspa, it is highly recommended you check with the manufacturer to see the recommended cleaning procedures to not only protect your clients but yourself.
