Fee Schedule

- A. The following fees apply to standards that are tested to ASTM Class 1 and OIML Class E1 & E2 tolerances and for calibrations reported with mass values. Adjustment of standards may be available on request at additional cost.

Customary	Metric	Fee/Unit
0 – 10 lbs	0 – 5 kg	\$23.50
11 – 50 lbs	10 – 30 kg	\$31.50

- B. The following fees apply standards that are tested to NIST Class S and S-1, ASTM Class 2 and 3 or OIML Class F1 tolerances. Adjustment of standards may be available on request at additional cost.

0 – 10 lbs	0 – 5 kg	\$18.00
11 – 50 lbs	10 – 30 kg	\$22.50

- C. The following fees apply to standards that are tested to NIST Class P, ASTM Class 4 and 5 or OIML Class F2 and M1 tolerances. Adjustment of standards may be available on request at additional cost.

- D. The following fees apply to standards that are tested to NIST Class C and F, ASTM Class 6 and 7 or OIML Class M2 tolerances. Adjustment of standards exceeding tolerance is included in calibration fee.
