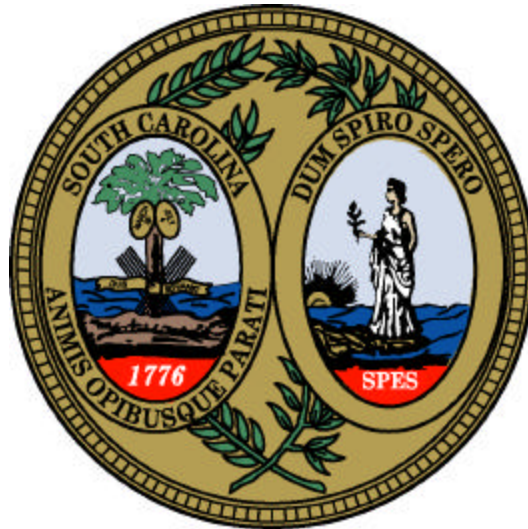

The South Carolina Department of Public Safety, Office of Justice Programs, is pleased to provide you with this publication, which offers a synopsis of each crime victim assistance project currently funded by our office.

Our three sources of victim assistance grant funds are the Victims of Crime Act (VOCA), the Violence against Women Act (VAWA), and the State Victims Assistance Program (SVAP). Each of the three funding streams represents a different generation source for their funds: federal crime fees and fines for VOCA; congressional appropriations for VAWA; and inmate/criminal assessments for SVAP. Combined, these funding sources represent more than \$8,594,000 in revenues for South Carolina specifically targeting projects to assist victims of crime.

The 208 projects currently being supported by these three grant programs provide critical services to the tens of thousands of South Carolina citizens who become victims of crime each year. I am proud to support the efforts of the dedicated staff and volunteers involved in these important state and community programs.
