

## **Frequently Asked Questions - Disaster Nutrition Assistance Program (DSNAP) Relief for Specific Counties Impacted by Hurricane Helene**

The Disaster Supplemental Nutrition Assistance Program, or “DSNAP”, is a temporary food assistance program that provides a one-time payment to household that have lost income or property damage due to a disaster.

### **Are all counties in South Carolina eligible for this program?**

As of November 1, 2024, the U.S. Department of Agriculture has approved only the following counties for DSNAP as a result of Hurricane Helene: **Abbeville, Aiken, Allendale, Anderson, Bamberg, Barnwell, Beaufort, Cherokee, Chester, Edgefield, Fairfield, Greenville, Greenwood, Hampton, Jasper, Kershaw, Laurens, Lexington, McCormick, Newberry, Oconee, Orangeburg, Pickens, Richland, Saluda, Spartanburg, Union, and York.**

Households that resided within one of these counties at the time of Hurricane Helene **AND** suffered unreimbursed disaster losses may be eligible to receive a DSNAP benefit. **Food loss alone is not a qualifying factor for DSNAP assistance.**

### **What will the process look like for households who need assistance?**

Non-SNAP recipients in the affected counties who are seeking assistance and were unable to pre-register and complete a telephone interview between November 12<sup>th</sup> and November 21<sup>st</sup> may apply in-person.

Each in-person event will run for three (3) days. Individuals can only apply for DSNAP at the designated location in their county of residence.

Beginning Sunday, December 1<sup>st</sup>, residents of **Allendale, Anderson, Bamberg, Barnwell, Beaufort, Cherokee, Hampton, Laurens, McCormick, Saluda, Spartanburg, Union, and York** counties may pre-register for DSNAP online, at <https://benefitsportal.dss.sc.gov/> and visit the DSNAP site in their county of residence during the scheduled period.

Beginning Sunday, December 8<sup>th</sup>, residents of **Abbeville, Aiken, Chester, Edgefield, Fairfield, Greenville, Greenwood, Jasper, Kershaw, Lexington, Newberry, Oconee, Orangeburg, Pickens, and Richland** counties may pre-register for DSNAP online, at <https://benefitsportal.dss.sc.gov/> and visit the DSNAP site in their county of residence during the scheduled period.

Please review the schedule of in-person DSNAP events at the end of this FAQ or on the DSS website.

### **What will I need to provide during the online pre-registration process?**

Applicants are encouraged to provide as much information as possible on the online pre-registration form. Households should be prepared to provide the following information:

- Name, date of birth, and Social Security number (if applicable) for each household member.
- Permanent residential address, temporary address, and/or mailing address.
- A driver's license or state-issued ID number.
- Amount of disaster-related expenses incurred during the disaster period.
- Amount of income for each household member.
- Amount of household resources, to include cash on hand or savings.

Failure to provide the requested information in the DSNAP pre-registration process may delay the determination of eligibility for DSNAP benefits.

**If I was denied DSNAP over the phone, can I reapply in-person in my county of residence?**

No. **Households who applied for DSNAP between November 11<sup>th</sup> and November 21<sup>st</sup> and were denied after a telephone interview are not eligible to re-apply.** If you do not agree with the decision made on your DSNAP application, you may request a fair hearing by calling 1-800-311-7220 or writing to your local county DSS office.

**What if I pre-registered for DSNAP but did not complete the telephone interview?**

If you completed the pre-registration process but did not complete a telephone interview, you can visit the scheduled onsite DSNAP event in your county of residence. You will need the confirmation/reference number provided at the completion of the pre-registration process to complete an in-person eligibility interview.

**Can I call or visit my local county or regional DSS office to apply for DSNAP?**

Online pre-registration and interviews cannot be completed at your local county DSS office. Calling or visiting your local DSS office will not expedite the application and verification process for DSNAP.

**What will be considered as a 'loss' related to Hurricane Helene?**

Applicants must have suffered a loss directly related to Hurricane Helene to be eligible for DSNAP benefits. Households applying for Disaster SNAP must have lived in the disaster area on September 27, 2024, **and** must have suffered loss or damages, such as:

- Damage to or destruction of the home.
- Loss or inaccessibility of income including a reduction or termination of income or a significant delay in receiving income due to disaster related problems.
- Disaster-related expenses (home or business repairs, temporary shelter, evacuation, etc.) that are not expected to be reimbursed during the disaster benefit period.

Individuals applying for DSNAP in-person should be prepared to provide the following:

- Proof of Identity
- Proof of Address
- Proof of Income
- Proof of the value of unreimbursed damages incurred as a direct result of the storms
- Proof of loss or inaccessibility of income

All DSNAP applications are subject to review. If it is determined that an applicant received benefits that he/she was not entitled to, the applicant will be required to pay them back.

**Is there an income limit for DSNAP? How much is the benefit?**

To qualify for DSNAP, a household's net income plus its accessible liquid resources minus any disaster-related expenses must not exceed the Disaster Gross Income Limit.

The Disaster Gross Income Limits and DSNAP allotment amounts are included below:

### **How will I receive my DSNAP benefits if approved?**

DSNAP benefits will be provided via an electronic debit-like card and can be used to purchase food items at authorized SNAP retailers. For approved items that can be purchased with DSNAP benefits, please visit: [What Can SNAP Buy? | Food and Nutrition Service.](#)

If approved for DSNAP benefits, the DSNAP EBT card will be issued onsite at the DSNAP event.

Households that completed a telephone interview can expect to have the benefits mailed to their home address on file with their application. Delivery time for DSNAP EBT cards is estimated to be three days from the date DSNAP is approved.

### **How can I prevent fraud with my DSNAP EBT card?**

Please do not use third party mobile apps for management of your SC EBT account.



### **My household already receives traditional SNAP benefits each month. Is my household also eligible for DSNAP?**

**No. Per federal rules and guidelines, current SNAP recipients are not eligible for DSNAP.** Current SNAP recipients who reside in a county approved for DSNAP and received SNAP during the month of October 2024 may be eligible for a disaster supplement if their monthly SNAP benefit is less than the maximum monthly allotment for their household size.

If approved, the amount of a SNAP household's disaster supplement will be equal to the difference between their October 2024 monthly SNAP benefit and the total maximum allotment amount for the household size. For example, a 3-person SNAP household whose October 2024 SNAP benefit was \$500 would receive a disaster supplement of \$268 (\$768 - \$500).

SNAP households that already receive the maximum allotment for their household size are not eligible for a disaster supplement.

This disaster supplement was already issued to current SNAP recipients residing in Abbeville, Aiken, Allendale, Anderson, Bamberg, Barnwell, Beaufort, Cherokee, Chester, Edgefield, Fairfield, Greenville, Greenwood, Hampton, Jasper, Laurens, Lexington, McCormick, Newberry, Oconee, Orangeburg, Pickens, Richland, Saluda, Spartanburg, Union, and York counties who qualify.

Current SNAP recipients residing in Kershaw County who meet all of the criteria listed below may go to the designated DSNAP site in Kershaw County between December 11<sup>th</sup> and 13<sup>th</sup> and file an Affidavit of Loss to request a supplement of their October SNAP benefits:

- a. Received SNAP in October 2024;
- b. Receive a monthly benefit that is less than the maximum monthly allotment for their household size; and
- c. Suffered a disaster loss.

**If approved, when will my household's DSNAP benefits expire?**

Unused DSNAP benefits will be expunged after 9 months (274 days) of inactivity.

**Where can I go to get additional information on the DSNAP process? Should I believe everything I read on social media?**

DSS reminds the public to be sure you are obtaining information from official sources and trusted news organizations to avoid confusion and misinformation. Additional updates will be posted to [dss.sc.gov](https://dss.sc.gov) as they become available, including information about the next round of online pre-registration and screening interviews and in-person events in December.
