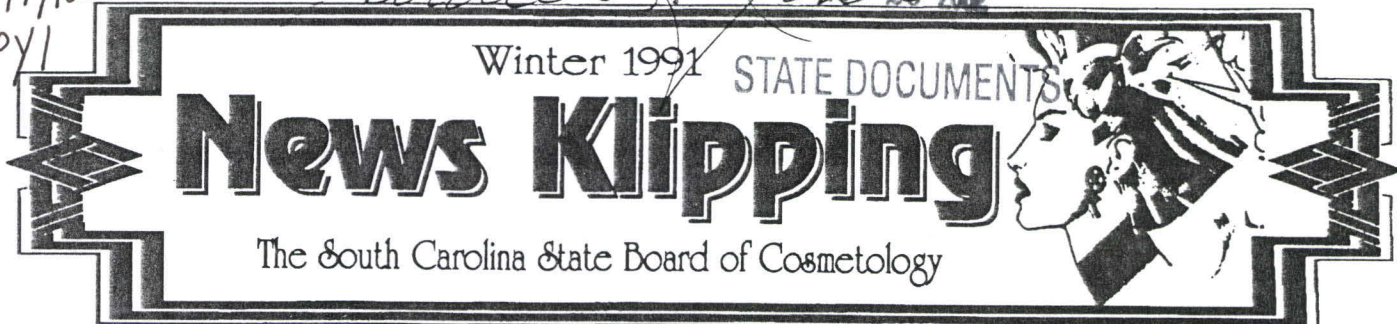

Executive Director Retires:

Mrs. Doris Brantley, Executive Director of the Board has announced her retirement effective January 1, 1991.

The Board recognizes the many positive changes that have taken place during Mrs. Brantley's tenure as Director. The agency has completely automated the licensing process with an in-house computer. This system now enables the agency staff to provide more accurate and timely information to those making enquires regarding the status of their license. The number of licensees has increased annually until today over 18,000 cosmetologists, manicurists, estheticians and instructors in addition to 5,200 salons are licensed by the Board.

The Board has selected a member of the agency staff, Mr. C. Arthur Pruitt to succeed Mrs. Brantley as Agency Director. Mr. Pruitt has been associated with the Board in various capacities for a number of years.

Members of the Board and the agency staff wish Mrs. Brantley well during her retirement years.

Continuing Education:

Every license holder must attend a Board approved Continuing Education class by December 31 in order to renew his/her license for the following year. Failure to attend Continuing Education class by December 31 will result in a penalty fee of \$15.00. Attendance at a Continuing Education class is for CEU Credit only. Payment of the required license fee to the State Board of Cosmetology must be made for a license to be issued.

Renewal Notices:

Renewal notices are mailed to licensees completing Continuing Education prior to December 31. If you have completed Continuing

Education prior to December 31 and do not receive a renewal notice it is your responsibility to send the correct fee and renew your license prior to the expiration date shown on the license.

It is a violation of the Cosmetology Practice Act to practice Cosmetology without a valid, current license or permit. Employers are responsible for visually inspecting the actual license or permit of each employee to assure compliance.

Name and Address Change:

You must inform the Board immediately of any change in name and/or address.

General Assembly Considers Crossover Between Licensed Cosmetologists and Master Hair Care Specialists (Barbers)

Responding to the needs of the industry, the Barber and Cosmetology Boards have proposed a regulation to the General Assembly whereby a Master Hair Care Specialists (Barber) could become eligible for examination for licensure as a Cosmetologist and a Cosmetologist could become eligible for examination for licensure as a Master Hair Care Specialists (Barber).

If this regulation is approved by the General Assembly, the Barber and Cosmetology Boards will meet to establish the requirements for crossover.

Statistics:

Over the past year January through December 1990 there were a total of 1520 individuals taking the Cosmetology, Esthetics and Manicuring exams. 1177 passed and 343 failed for a passing percentage of 77%.

Ninety-four letters of reprimand to salon owners concerning discrepancies in inspection and of having unlicensed individuals working in salon.

Examination Schedule:

Examinations are scheduled by the Board to be held every month on the second Monday in Columbia at the Town House Hotel, Gervais Street.

Examinations are also held during May at six other sites for the graduating secondary students.

discovered during the course of inspection, the deficiency is brought to the attention of the salon owner/manager for recommended corrective action and is noted on the inspection report as well. The inspection report

owner/manager and is also noted on the inspection report as a second violation. The report must be posted in the salon.

(5) The second deficiency is filed by the inspector with the Board.

(6) Notice of alleged violation is mailed by the Board to the salon owner/manager with a time frame designated in which corrective measures are to be made.

(7) If no response is received by the Board from the salon owner/manager of intent to correct deficiency or note that corrective measures have been taken within thirty days from the date of notice, an official notice is sent to salon owner to appear before the Board to show just cause why further action should not be taken.

The Board of Cosmetology, Inspector or any authorized representative of the Board may enter the premises of any salon at anytime during normal working hours, and in such manner as not to interfere with the operations of the salon, to determine whether or not the salon is in compliance with the Cosmetology Act and the inspection rules of the Board.

(1) Should a deficiency be

must be posted conspicuously in the salon.

(2) The initial deficiency (copy of inspection report) is filed by the inspector with the Board.

(3) During the next following inspection of the salon, the inspector makes note of whether the deficiency has been corrected.

(4) If the deficiency has not been corrected, it is again brought to the attention of the salon
