JUSTIFICATION OF REQUEST	<p>A salary analysis for the LAC was conducted by an outside firm in 2014. The analysis noted some disparity in salaries, as well as, some salary compression. In addition, the LAC has surveyed similar audit agencies in other states to compare auditor compensation. The LAC has experienced a turnover in the audit staff of approximately 30% in the last 18 months. To maintain a well-qualified and productive audit staff and to reduce turnover, additional salary adjustments are needed.</p> <p>The only other available source of funds would be Other Funds obtained by billing agencies for audits. Since we do not know which agencies the General Assembly will request us to review, or if they have Federal Funds available that we can match, we do not know if we will be able to obtain these funds. The amount of Other Funds received varies from year to year and are not be a stable source of funding. Recurring funds are a better source to address Personal Services matters. The amount requested includes salary adjustments and employer contributions.</p>
