Note: For all of CY 2005 and for the first six months of CY 2006, the number of juvenile/juvenile “nonconsensual” sex acts reported included consensual sex if one or more of the participants were under age 16. Effective July 1, 2006, South Carolina’s consensual sex law changed to require that one of the participants be over 18 for the consensual sex to be considered nonconsensual, if the other participant is 14 or older.
