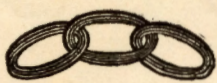

**Rules and Regulations**

**RULE I**

All persons joining the Order or Association as a new member, shall pay to the Lodge not less than Two (\$2.00) to become a member of the Charitable Department of the Grand Lodge, and will be entitled to a Certificate of Membership therein.

**RULE II**

The dues of this Charitable Department shall be One (\$1.00) Dollar per member each Quarter, payable on or before the twentieth (20th) day of January, April, July and October, in each year.

**RULE III**

Any member failing to make their regular payment to this fund for one quarter, shall not be entitled to any donation from the Charitable Department.

**RULE IV**

Any member who had become non-financial may become re-instated by paying all back dues and Two Dollars (\$2.50) and Fifty Cents to

become beneficial, providing he or she is not over fifty (50) years of age, and on filing a Medical Certificate of good health. A new certificate will be issued.

**RULE V**

The District Grand Secretary shall be Secretary and Treasurer of the Charitable Department of the Order.

**RULE VI**

The Board of Directors, shall alter, change or amend these Rules and Regulations as the good of the Order and the Charitable Department may require.

**RULE VII**

Any previous certificate or policies held by any member and any certificate or policy number not recorded on the Secretary's Roll, in keeping with the actions creating the Charitable Department shall be null and void and of no effect.
