Our expected results are for state government to realize financial benefits and improve its operations by implementing the recommendations in our audits.

Outcome Measures:

In FY 07-08, we published four performance audits, identifying potential financial benefits of approximately \$1.6 million and making 72 recommendations to improve state government. We published three follow-up audits, finding that 43% of our recommendations from prior years had been implemented. We were also awarded the 2008 Excellence in Evaluation Award from the National Legislative Program Evaluation Society.
