Service Coordination News

SCDDSN implemented an electronic service note system on the Consumer Data Support System (CDSS) for Service Coordination providers to use no later than July 1, 2010. The electronic service note system should prove to save time when reporting core job functions. Once service notes are entered and completed on CDSS, the service notes are electronically transmitted to SCDDSN where billing is determined by the system (based on the values entered by Service Coordinators) and forwarded to Medicaid. Since the system will determine what will be billed to Medicaid, Service Coordination Service Provision Logs and Supervisor review of reportable core job functions will no longer exist, thus, saving some staff time. For more information on how the service note system works, please access training videos under “Business Tools” in CDSS.

The SC Standards are being updated as a result of the new electronic service note system, the Department of Health and Human Services’ 2010 Targeted Case Management Manual, and recommendations from a review of the DDSN Service Coordination program completed by the “National HCBS Quality Enterprise”. Please send in your comments to Angela Syphertt by June 25th!

Recently, SCDDSN was advised by the DHHS that nursing services for children under 21 are funded via the Medicaid State Plan. A memo went out to providers from the SCDDSN this month giving instructions on what to do for every child served who receives nursing services. Updates to the Service Coordination Standards and Waiver manuals regarding nursing services for children are forthcoming.

INFORMATION TECHNOLOGY

FROM THE DESK OF DAVID FOSHEE

Did you know that DDSN has a report delivery system called R2D2?

R2D2 is software that allows DDSN to create and deliver reports via an internet browser window.

We have approximately 300 reports in R2D2.

The reports are organized into Folders that correspond to the application that they support.

The Consumer Detail and Consumer Summary sub -folders under the CDSS folder contains over 30 reports. These reports provide valuable caseload information to DDSN providers, including such reports as:

- Caseloads by Worker (which displays a listing of all consumers under each SC/EI at a provider location)
- MR/RD, Early Intervention, and HASCI Service Coordination Summary reports (which display count totals of consumers for each SC/EI at a provider location)
- Service Coordination Levels (which displays the SC Level information for each consumer under each SC/EI at a provider location)
- Master Listing of Consumers Served (which display a listing of consumers in alphabetical order receiving SC/EI services at a provider location).

The WVR (or Waiver) folder contains over 70 reports that provide valuable waiver information for DDSN providers, including such report as:

- Level of Care (which provides a listing of consumers and their last Level of Care dates)
- Various WVR Credit reports (which display listings of waiver consumers and their delivered services information from DHHS)
- PDD & CSW Waiting List reports (which display a listing of consumers on the waiting list for these types of waivers)
- PDD Enrollment Status report (which displays the current enrollment status for all the PDD consumers at a provider location)

Our latest addition to R2D2 is a number of new reports in the Service Notes sub-folder under the Services sub-folder under the CDSS folder, this folder includes such reports as:

- Activity Type Totals (which displays a listing of consumer and counts that report on the type of activities being reported on their Service Notes)
- Service Notes by Time Frame (which displays all the services notes for a chosen consumer during a given time frame)

Applying for DDSN Services

Effective July 1, 2010, DDSN will begin contracting with the University of South Carolina, School of Medicine, Center for Disability Resources (USC - CDR), to screen individuals applying for DDSN services. This function has been performed by local disabilities and special needs boards. Any person suspected of having mental retardation, a related disability, autism or children ages 3 to 6 years old with significant developmental delays will call USC - CDR toll-free at 1-800-289-7012 to apply for DDSN services. This toll-free line will be staffed during normal business hours; however, messages can be left at any time with calls returned the next business day.

If an applicant is screened in, USC – CDR will provide the applicant with a list of available service coordination providers, or if the applicant is 3 to 6 years old, a list of available early intervention providers. USC – CDR will record the applicant’s top 2 choices and contact the selected SC/EI provider to inform them of the referral. The SC/EI provider will have 4 working days to accept or decline the referral. Once accepted, the SC/EI provider will get in touch with the applicant to begin collecting the necessary information and reports required for formal consideration of DDSN eligibility.

For individuals applying for DDSN services suspected of having a traumatic brain or spinal cord injury or similar disability, the toll-free telephone number remains 1-866-867-3864.

Community Support Waiver

Public Meeting to Discuss Amendments

The Department of Health and Human Services and the Department of Disabilities and Special Needs are holding a public meeting to review upcoming proposed amendments to the Community Support Waiver. The meeting will take place at DDSN located at 3440 Harden Street Extension, Columbia, SC 29203 on July 8, 2010 and begin at 6:00PM until 7:30 PM. DHHS will request an effective date of October 1, 2010 or as soon thereafter from The Centers for Medicare and Medicaid Services.

The proposed amendments are:

- 1. To clarify the individual cost limit in the waiver document. There is no negative impact to waiver participants.**
- 2. To update the Quality Management sections of the waiver document to more accurately reflect the data sources used by the State. There is no negative impact to waiver participants.**
- 3. To clarify that Level of Care determinations and service plans for waiver participants must be completed every 365 days. There is no negative impact to waiver participants.**
- 4. To eliminate daily respite and convert all respite to an hourly unit. There may be a few participants that will be affected by this change. However, the waiver individual cost limit remains the same.**
- 5. To reduce the amount by which the individual cost limit may be exceeded in the event of a short-term, unanticipated change in the participant's needs from \$3000 to \$1000 per year. To date, no waiver participant has exceeded the individual cost limit.**
