Did You Know.....

The Board chair shoulders many responsibilities

Planning—The Chair works with the director to plan the meeting agenda and the manner in which the meeting will be conducted. The Chairperson keeps an overall view of the board year and ensures that the board is completing duties mandated by board policy or law.



Presiding/Facilitation—The Chair must ensure adherence to the agenda and completion of items on the agenda. The Chair must also ensure fair participation for all board members and fair exposure to all sides of an issue. The Chair must keep the meetings moving forward in a professional and timely manner and, finally, move the board to action on the issues. (cont'd on page 2)

Responsibilities of the board chair

“...it is the duty of the Chairperson to promote teamwork among board members.”

Delegation—The Chair traditionally has the power to appoint board members and others to committees with board consent. To do this well, the Chair must have a clear understanding of each board member’s skills, strengths and interests so that appropriate assignments can be made.

It is also the Chair’s responsibility to make sure that committee assignments are clear and to hold the committees accountable to do the job assigned. The Chair is often an ex-officio member of every committee.

Liaison—The Chairperson must be able to communicate board needs and concerns to the director and the director’s needs and concerns to the board. In addition, the Chair offers personal support and counsel to the director, and serves as a sounding board for the director.

Team Building—The board must always function as a team and it is the duty of the Chairperson to promote teamwork among board members. It may be necessary for the Chair to mediate and counsel fellow board members if the board fails to function as a team on occasion.
