Fines and Fees Report FY2022

September 1, 2022

Pursuant to Proviso 117.73 the Commission reports the following aggregate amounts of fines and fees charged and collected by the Commission during FY2022.

Hearing Fee -- \$1,048,500

As authorized by Part 1B Section 74.2 of the 2021-2022 Appropriations Act the Commission collected hearing fees from claimants, attorneys, and insurance carriers for a \$50.00 filing fee for each request for hearing, settlement, or motion. The funds were utilized for the operations of the Commission (Section §42-3-105).

Self-Insurance Application Fee -- \$7,350

As authorized by SC Regulation 67-1501 F (2) the Commission collected a \$25.00 filing fee from employers accompanying an application to the Commission for membership in a self-insurance fund. The funds were utilized for the operations of the Commission (Section §42-3-105).

Filing Violation Fee -- \$1,589,397

Pursuant to Section §42-19-30 of the SC Code of Laws, the Commission is authorized to collect from an employer or an insurance carrier a penalty fee of not less than ten dollars nor more than one hundred dollars for each refusal or neglect for violations of filing required forms, records and reports as necessary for the proper handling or adjudication of a claim. The funds were utilized for the operations of the Commission (Section §42-3-105).

The Commission is authorized to collect a penalty of not less than one hundred dollars and not more than two hundred fifty dollars for each day of failing to file a report of insurance coverage from an insurance carrier within 30 days from the inception date of the coverage (Section §42-19-50). The funds were utilized for the operations of the Commission (Section §42-3-105).

Award Review Fee -- \$25,250

Section 42-17-50 authorizes the Commission to collect a fee for each application for commission review. The fee is \$150 and is equal to that charged in circuit court for filing a summons and complaint. The funds are to defray the costs of the review.

Training Conference Fee -- \$800

As authorized by Part 1B Section 74.1 of the FY2021-2022 Appropriations Act, the Commission is authorized to retain all revenue earned from educational seminars for the printing of educational materials and other expenses related to conducting the seminar. The agency sponsored one educational seminar for stakeholders. The funds collected were registration fees from attendees.

Photocopying fee -- \$86,872

The Commission provides copies of documents related to claims filed with the Commission. As authorized by Section §30-4-30 of the SC Code the Commission charges \$20.00 for research and the first 20 pages produced and \$.50 per page for each page thereafter.

Sale of listings and labels -- \$2,603

Revenues collected for copies of documents related to claims filed with the Commission, listings of proof of coverage transactions research of individuals claims filed with the Commission. The Commission charges \$20 for research and the first 20 copies and \$.50 per page for each page thereafter. Proof of coverage transactions subscriptions are \$300 per year and research for an individual's claim history is \$25 per individual (Section §30-4-30 of the SC Code).

Pursuant to Proviso 117.73 the Commission reports the following aggregate amounts of fines and fees charged and collected by the Commission during FY2022.

Hearing Fee -- \$1,048,500

As authorized by Part 1B Section 74.2 of the 2021-2022 Appropriations Act the Commission collected hearing fees from claimants, attorneys, and insurance carriers for a \$50.00 filing fee for each request for hearing, settlement, or motion. The funds were utilized for the operations of the Commission (Section §42-3-105).

Self-Insurance Application Fee -- \$7,350

As authorized by SC Regulation 67-1501 F (2) the Commission collected a \$25.00 filing fee from employers accompanying an application to the Commission for membership in a self-insurance fund. The funds were utilized for the operations of the Commission (Section §42-3-105).

Filing Violation Fee -- \$1,589,397

Pursuant to Section §42-19-30 of the SC Code of Laws, the Commission is authorized to collect from an employer or an insurance carrier a penalty fee of not less than ten dollars nor more than one hundred dollars for each refusal or neglect for violations of filing required forms, records and reports as necessary for the proper handling or adjudication of a claim. The funds were utilized for the operations of the Commission (Section §42-3-105).

The Commission is authorized to collect a penalty of not less than one hundred dollars and not more than two hundred fifty dollars for each day of failing to file a report of insurance coverage from an insurance carrier within 30 days from the inception date of the coverage (Section §42-19-50). The funds were utilized for the operations of the Commission (Section §42-3-105).

Award Review Fee -- \$25,250

Section 42-17-50 authorizes the Commission to collect a fee for each application for commission review. The fee is \$150 and is equal to that charged in circuit court for filing a summons and complaint. The funds are to defray the costs of the review.

Training Conference Fee -- \$800

As authorized by Part 1B Section 74.1 of the FY2021-2022 Appropriations Act, the Commission is authorized to retain all revenue earned from educational seminars for the printing of educational materials and other expenses related to conducting the seminar. The agency sponsored one educational seminar for stakeholders. The funds collected were registration fees from attendees.

Photocopying fee -- \$86,872

The Commission provides copies of documents related to claims filed with the Commission. As authorized by Section §30-4-30 of the SC Code the Commission charges \$20.00 for research and the first 20 pages produced and \$.50 per page for each page thereafter.

Sale of listings and labels -- \$2,603

Revenues collected for copies of documents related to claims filed with the Commission, listings of proof of coverage transactions research of individuals claims filed with the Commission. The Commission charges \$20 for research and the first 20 copies and \$.50 per page for each page thereafter. Proof of coverage transactions subscriptions are \$300 per year and research for an individual's claim history is \$25 per individual (Section §30-4-30 of the SC Code).
