Take a photo of a historically significant building, home, area, piece of land, etc., and email it to: [ghardee@scdah.sc.gov](mailto:ghardee@scdah.sc.gov). In the subject line, place the words "photo contest." Please provide a description of the photo and a few sentences describing what it means to you. Be as creative as you want, but special consideration will be given to South Carolina's National Register properties. For a list of South Carolina's National Register

properties, visit: <http://www.nationalregister.sc.gov/>. Entries must be received by 5 p.m. on April 25, 2015 and must be in .jpg format in their full resolution.

We will pick the top ten photos and display them on our [Facebook page](#), and will then let our followers choose the winner. We will give each person credit for his or her photo. However, by sending it in, you give the South Carolina Department of Archives and History permission to use the photo online or in publications. (Regardless, you will still always be credited for your work.) Please submit your own work, and make sure you do not trespass on private property in order to get your photo. Historic organizations may also submit photos, but they must be taken by a member of the organization.

## **Preservation50**

2016 will mark the 50th anniversary of passage of the National Historic Preservation Act, the country's most important preservation law. Among other things, the law established the National Register of Historic Places as the nation's official list of historic resources worthy of preservation. It also provided for state and tribal preservation offices, Certified Local Government programs, the Section 106 planning and review process to take into account the effect of federally supported projects on historic properties, and a preservation fund derived from proceeds of Outer Continental Shelf oil and gas leases. ## **Updated National Register Listing in North Carolina Has South Carolina Ties**

The National Register of Historic Places recently accepted a newly completed nomination for the Flat Rock Historic District in North Carolina. Flat Rock was established as a summer resort by South Carolina planters seeking to escape the heat and unhealthy conditions of the Lowcountry. Listed in the National Register for more than forty years, the Flat Rock Historic District documentation and district boundaries were re-examined, and the new nomination fully describes and delineates the historic buildings and landscapes in the resort community, and also examines the town's 20th-century development and architecture through 1965. ## **Tax Credit Historic Rehabilitation Awards**

The Novogradac Journal of Tax Credits Historic Rehabilitation Awards honor outstanding achievement in the rehabilitation of developments by recognizing development teams for excellence in the creative use of the historic tax credit (HTC). To be eligible for the 2015 awards round, historic rehabilitation projects will have been financed at least in part with historic tax credits, placed in service in 2014 or by May 1, 2015, and:

- had a meaningful and major impact on their community;
- demonstrated financial innovation; or
- overcame significant obstacles in their development.

### **Grant Application Deadlines**

**NEW May 1, 2015** Several **National Trust for Historic Preservation** grant applications are due May 1, 2015:

- [Cynthia Woods Mitchell Fund for Historic Interiors](#), awarding grants for the planning phases of interior restoration projects. Grants range from \$2,500 to \$10,000 and require a dollar-for-dollar match.
- [Hart Family Fund for Small Towns](#), providing preservation planning and education grants to projects taking place in communities of fewer than 5,000 people. Grants range from \$2,500 to \$10,000 and require a dollar-for-dollar match.

- [Johanna Favrot Fund for Historic Preservation](#), providing funding to deserving organizations demonstrating commitment to the protection of natural and cultural resources in the Mid-Atlantic region. Grants typically fall in the \$1,000 to \$2,000 range and no match is required.

**NEW May 5, 2015 National Endowment for the Humanities Preservation Assistance Grants for Smaller Institutions.** Preservation Assistance Grants help small and mid-sized institutions—such as libraries, museums, historical societies, archival repositories, cultural organizations, town and county records offices, and colleges and universities—improve their ability to preserve and care for their significant humanities collections. These may include special collections of books and journals, archives and manuscripts, prints and photographs, moving images, sound recordings, architectural and cartographic records, decorative and fine art objects, textiles, archaeological and ethnographic artifacts, furniture, historical objects, and digital materials. **NEW June 15, 2015 Underrepresented Community Grants (National Park Service).** Grant-supported projects include surveys and inventories of historic properties associated with underrepresented communities, as well as the development of nominations to the National Register for specific sites. Eligible applicants are Certified Local Governments, SHPOs, Federally recognized tribes, Alaska Native Organizations, and Native Hawaiian Organizations.
