## MEDICAID BULLETIN

**TO: All Providers**

**SUBJECT: Rate Increases for Certain Incontinence Supplies and DAODAS and ASD Services**

Effective Jan. 1, 2022, the South Carolina Department of Health and Human Services (SCDHHS) will increase the reimbursement rates for the services and supplies mentioned below. These rate increases apply to the Current Procedural Terminology (CPT) and Healthcare Common Procedure Coding System (HCPCS) codes included in this bulletin.

### Incontinence Supplies

SCDHHS will increase the reimbursement rates for incontinence supplies billed using the HCPCS codes listed below by 10%.

These changes will be reflected in the Durable Medical Equipment (DME) and the Community Long Term Care (CLTC) [fee schedules available on SCDHHS' website](#) by Jan. 1, 2022.

**Department of Alcohol and Other Drug Abuse Services (DAODAS) Services**

SCDHHS will increase the reimbursement rates for addiction services billed using the HCPCS codes listed below by 15%.

Code	Description
H0001 (with modifiers HO, HN, TS, UC, TD and U2)	Alcohol & Drug Assessment
H0004 (with modifier GT)	Individual Alcohol/Drug Substance Abuse Counseling
H0011	Alcohol/Drug Services Detox Residential
H0015	Alcohol/Drug Services Intensive OP Treatment Level II.i (hourly)

SCDHHS will also update the reimbursement rates as depicted below for DAODAS peer support services billed using the following HCPCS code:

Code	Description	New Rate
H0038	Individual	\$10.74
H0038 (with modifier HQ)	Group	\$1.79

**Autism Spectrum Disorder (ASD) Services**

SCDHHS will update the reimbursement rates as depicted below for ASD services billed using the following CPT codes:

Code	Description	New Rate
97153	Treatment - RBT	\$45/hour
97155	Treatment - BCBA/BCaBA	\$85/hour
97156	Family Training	\$85/hour
