



## Annual Report on Added and Terminated Programs

*July 1, 2023- June 30, 2024*

### Background

This report provides an overview of academic program activity from July 1, 2023, through June 30, 2024, identifying academic degree programs that have been added or terminated from an institution's academic catalog, program concentrations that have been added or terminated, changes to the instructional sites or modalities of an academic program, and certificates added or terminated. The report also provides a summary of program activity by curricular area and institution, and a comparison of academic program changes over the past ten years.

The added programs went through 2-3 rounds of staff revisions with the submitting institutions prior to placement on the Advisory Council on Academic Programs (ACAP) agenda for consideration. Some programs underwent further revisions post ACAP after receiving intuitional feedback and before being reviewed by the Committee on Academic Affairs and Licensing (CAAL). On average, there have been more programs added than terminated. The majority of the additions have been bachelor's and master's degrees. The net change in the number of academic programs, concentrations, instructional sites and modalities, and certificates has been greatest in the fields of business, marketing, and management; teacher education; engineering; health professions; and computer and information sciences. This growth in programs is well aligned with state workforce needs.

### Addition of Degree Programs

During AY 2023-2024, ten institutions (two research, four professional doctorate, and four comprehensive) added a total of 28 degree programs. The added programs fell largely into five categories: STEM/Healthcare (45%), Education (24%), Criminal Justice (14%), Sport Psychology/Media and Public Relations (10%), and Business (7%). These programs were added in response to identified needs, program productivity, and alignment with the [Unified State Plan](#).

Table 1 shows the academic programs that have been added within the AY 2023-2024 by institution and degree. Table 2 shows the count of degree programs added by institution with most of the added programs at the baccalaureate level (62%) followed by master's degree programs (31%).

Table 3 shows the number of new programs added by the South Carolina Technical College System (SCTCS), which included the addition of five new programs at four institutions. 80% of the new programs added were in the science and/or medical fields.

Table 4 provides a summary of all of the terminations for AY 2023-2024 by institution. Table 5 and Figure 1 show the number of added and terminated programs by section. Research institutions added 35% and terminated 48% of programs, with the highest percentage of programs across sectors, followed by the addition of 33% of programs by professional doctorate institutions and termination of 28% of programs by comprehensive institutions.

Of the programs terminated, the highest percentage of terminations (36%) were for master’s degree programs, followed by (32%) certificates. The least number of terminations (8%) were bachelor degree programs and master’s degree concentrations. Additionally, 16% of associate degrees were terminated during AY 2023-2024. Tables 6-9 present a breakdown of terminations by degree type and institution.

Figure 1: Added and Terminated Programs by Sector (AY 2023-2024)

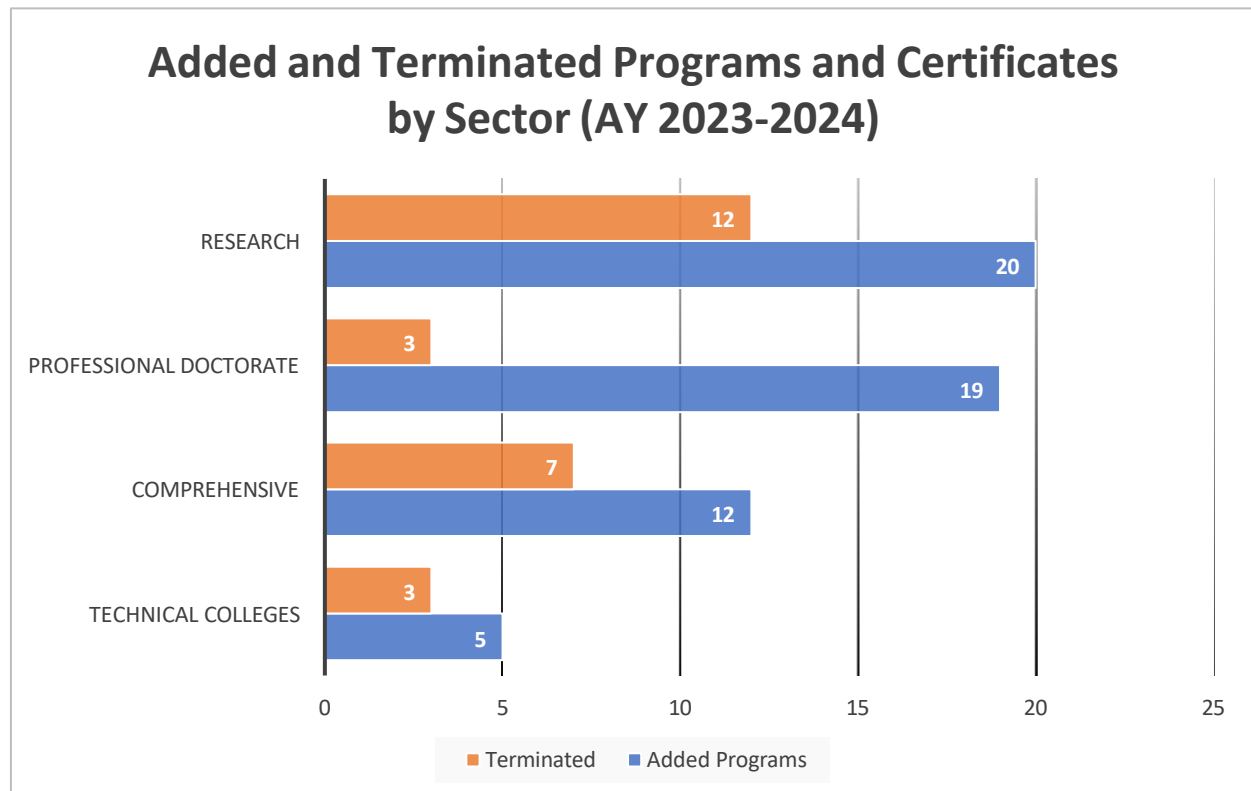


Table 6 provides a summary of certificates added in AY 2023- 2024. Certificates were added at the undergraduate, post bachelorette, and post master’s level. Over 30% of the new certificates were in STEM and/or Education which is in alignment with the state’s unified state plan and workforce development needs.

Tables 7-11 break out the terminations by type and university, including terminations of concentrations, certificates, associate degrees, bachelor’s degrees, master’s degrees, and the change in modality of programs offered. Changes in concentrations (20) represented the most frequent change made in AY 2023-2024, followed by changes in modality (17) primarily from face-to-face to hybrid or 100% virtual program or concentration delivery. Conversely, only one B.A. degree was terminated in AY 2023-2024.

Table 7 summarizes the certificate terminations for AY 2023 – 2024 by institution, with 50% of the certificate terminations from a research institution.

Table 10 summarizes the master’s degree terminations for AY 2023- 2024, with 56% of the M.A. degree program terminations from a research institution and 44% of the remaining terminations of master’s degrees from a research, professional doctorate, and comprehensive institution respectively.

In AY 2023-2024, 17 programs added or changed mode of program delivery to hybrid, blended, distance, or 100% online. 47% of the modality changes were within master's degree level programs while 40% of the modality changes were within bachelor level programs.

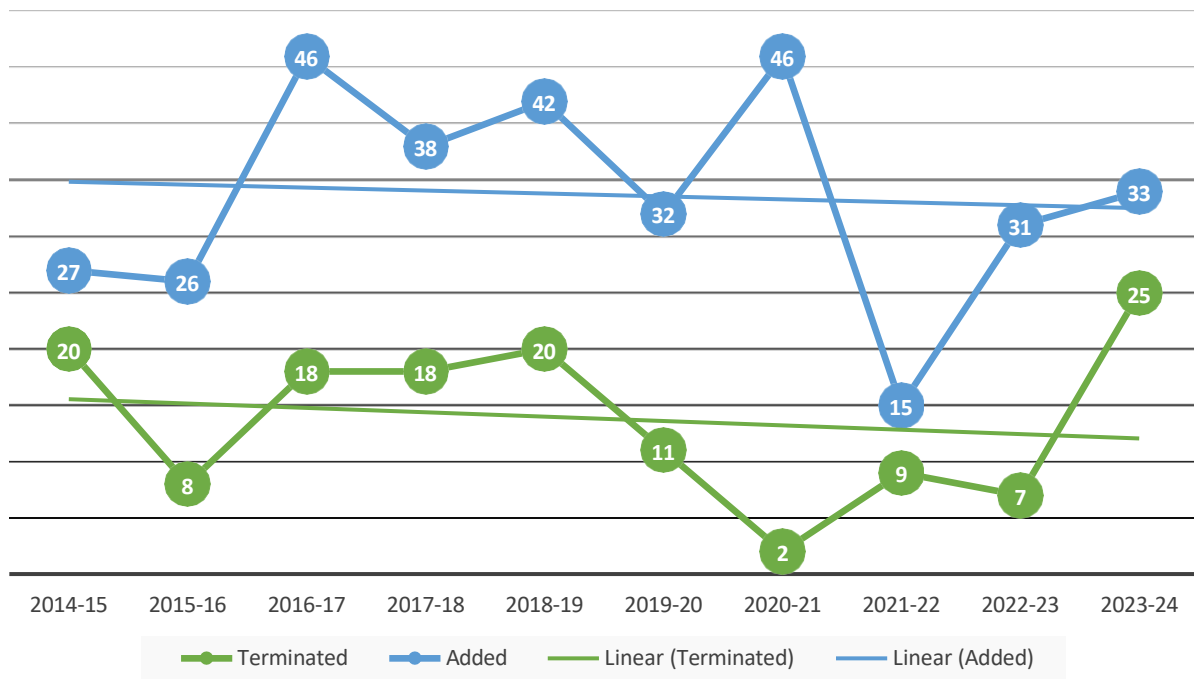

Figure 2 summarizes added and terminated degree programs over 10 years. There were 138 programs terminated and 337 new programs added from 2014-2024. The highest numbers of new programs added occurred between 2015-2021 (Range 32-46) with a downward trend in the addition of new programs from 2021-2024 (Range 15-34). There was a slight increase in the number of new programs (2) from 2022-2024. The lowest number of new programs added (15) occurred in 2021-2022, which demonstrates the potential impact of the COVID pandemic. Post pandemic, an increase in new programs (16) occurred in 2022-2023, with only a net gain of two new programs added in 2023-2024. An average of 34 new programs per year have been created in South Carolina over the past 10 years (2014-2024), while an average of 13.8 programs have been terminated per year over the past 10 years (2014-2024.)

## Conclusions

On average, the rate of program additions and terminations is decreasing. Terminations, as can be seen in Figure 2, are decreasing faster, on average, than additions. However, in 2023-2024, there was a +18 net increase in program terminations which may be a result of institutions working to align their program offerings with program productivity requirements and workforce development efforts.

In AY 2023-2024, the most program growth occurred in STEM/Healthcare (45%) and Education (24%), which aligns with priority occupations identified within the Unified State Plan. The job market in South Carolina is strong for each of these fields, and the need for graduates in each of these fields is well documented. While programs in education and health professions were the most added programs, they were also the most terminated programs. This trend is reflective of changing requirements of accreditation and licensure, as well as the desire to help students move through the pipeline to employment as quickly and easily as possible.
