State Classification IV – Recreation/Local Service (SC-IV): Recreation/Local Service airports typically demonstrate low activity and are forecasted to remain fairly level. They provide very limited airport facilities and services, and may have safety or development constraints that limit their need as well as their ability to expand. Runway lengths are typically less than 3,600 feet x 60 feet in width with Airport Reference Code (ARC) designations of A-I or B-I. Constraints may take the form of severe topography, airspace conflicts, environmental or land use obstacles, or other Corporate or Business Airports that provide competing facilities and aeronautical services. Recreation/Local Service airports should not be designed to support instrument approach procedures except in specific instances where there is a need for emergency response in an area that is geographically isolated.
