## **REGISTRATION NEWS**

### **Basic Mandated Registration**

We are very excited to offer a **NEW** way to register your Basic Law, Basic Jail and Limited Duty candidates. We have a **NEW** online registration form. Please make sure you print the form before you click submit, so you have a copy for your records. Once the online form is completed and submitted electronically, you can send your candidate to the Academy for registration with only their completed medical form and a picture ID. Once we review the medical, we will fingerprint them and assign them a class. Registration is held on Tuesdays, Wednesdays and Thursdays from 9 am to 3:30 pm.

### **Patrol Canine Teams Certification**

Chapter 23, Title 23 of the 1976 Code has been amended by adding:

"Section 23-23-140 (A) For purposes of this section, 'patrol canine teams' refers to a certified officer and a specific patrol canine controlled by the handler working together in the performance of law enforcement or correctional duties. 'Patrol canine teams' **does not** refer to canines used exclusively for tracking or specific detection.

(B) The South Carolina Criminal Justice Academy shall verify that patrol canine teams have been certified by a nationally recognized police dog association or similar organization.

(C) No law enforcement agency may utilize patrol canine teams after July 1, 2014, unless the patrol canine teams have met all certification requirements."

The Academy now has the Canine Certification process up and running. The form for the initial certification can be found under the "Forms" link at the top of the SC Criminal Justice Academy's homepage and it is listed under "K9 Certification". The Academy will process and assign initial certifications. Once certified, the officer will be granted Acadis portal access in order to self-renew the canine certification on an annual basis. The requirements for renewal will be the same as the initial certification (name of canine, selecting an approved organization that granted the certification, and uploading a copy of the certificate). 


## RETIREMENTS

## EMPLOYEE SPOTLIGHT

Chris Montjoy a Basic Detention Instructor at the Academy recently completed his EMT Certification. The EMT Basic course consisted of 200 hours of classroom study ranging from legal issues to trauma/medical assessment skills. The course consisted of classroom lecture and practical exercises that required each student to assess patients and provide proper medical attention. Students also had to do ride alongs with local EMS Units and assess at least four patients and provide a proper medical report. Section tests were given and students were required to maintain at least an 80% average to include successfully passing the practical assessments for each section. After completing the course a Final Cognitive and Psychomotor Exam was given and the student had to score at least 80% on the Cognitive and 100% completion of the Psychomotor Skills. Chris was elected class leader by his peers.

After completing the Midlands Technical College Basic EMT Course, Chris successfully completed the National Registry Exam and the Psychomotor and Cognitive Exam, which are both requirements to be licensed to treat patients in the State of South Carolina. Congratulations to Chris on his accomplishment.
