## Ethics Workshop a Huge Success

Consider these hypothetical situations:

- Your firm is short-listed for a major project at a state university. Prior to awarding the commission, a member of the selection committee asks you to contribute to an association to which several members of the committee belong. You get the impression that you will not be considered for the project unless you make the contribution.

- You are asked by an out-of-state architect (who is also a friend and former classmate) to seal plans for a four-story medical office building to be constructed in your state. Due to an oversight, his application for licensure was never filed with the state board. His client is pushing for go-ahead, contractors are ready to begin, and he is in a tight spot. You know he is a good architect and has an excellent reputation. What is wrong with carefully reviewing his design documents and calculations, ensuring state and local codes are met, and sealing the plans?

These kinds of ethical dilemmas were discussed at a workshop sponsored by the Board of Architecture and Clemson University's Department of Philosophy and Religion in June. Led by ethics professors Dr. Dan Wueste and Dr. Steve Satris and a panel of four licensed architects, the one-day workshop offered a unique forum for learning about ethical systems and for openly discussing, debating and evaluating ethical dilemmas encountered in practice.

The four architects each presented a personal ethical dilemma for discussion and then related the actual outcome. The architects represented a large firm, small and mid-size firms and a land development company. Their wide range of experience brought varied perspectives to the day.

The professors briefly outlined four ethical systems or approaches and used these systems as background for discussing scenarios. Break-out groups were assigned different case studies from a new textbook,

Ethics and the Practice of Architecture, written by architects. The groups were challenged to discuss the situation, determine how they would handle it, and report back to the entire group on the "solution" they proposed. There was spirited discussion, thoughtful commentary—and the solutions were diverse and creative. The workshop atmosphere—structured but informal—encouraged candid conversations about personal beliefs, ethical boundaries, competition in the profession today, and why seminars such as this one are necessary. It was an outstanding day! Participants left with much to think about, an interesting book to read, and a challenge to continue the discussion in their offices.

You might ask, "Why have a workshop on Ethics in Architecture?" "Why spend an entire day discussing hypothetical situations? What good will it do?" "Ethics is an

individual thing,” you might say. “Ethics is an interesting topic for intellectual debate, but I am confronted with practical problems every day and don’t have time to debate ethics.”

Is it really important? The Board thinks so, and so does the public. By granting “professional” status, the public has expectations of high standards of conduct and ethical behavior by architects. It is important enough to be an essential component of our registration law. Architects are not only expected to practice ethically, but they are required to do so.

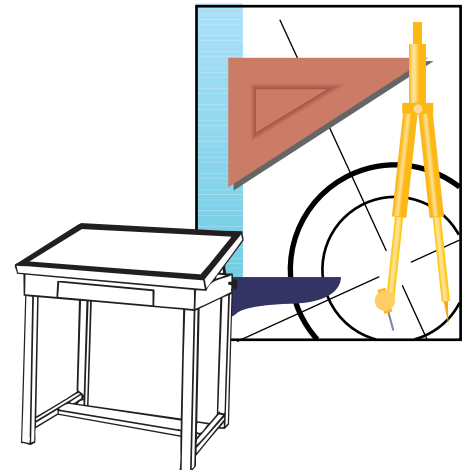
So, what happened in the two ethical dilemmas presented earlier? The architect declined to contribute to the association and was not awarded the project. He did, however, get additional projects at the university and today still provides services there. The second architect declined to seal the plans for his friend and colleague because it was against state law and to do so would have jeopardized his license. Because he did not originate the design and plans, he knew he couldn’t ethically “claim” them by sealing them. His response was both legal and ethical.

# Continuing Education

In June, the South Carolina Legislature granted the Board authority to require 12 hours of continuing education annually for license renewal. Eight hours must be in topics related to health, safety, welfare; four hours may be in practice-related topics. Other specifics—acceptable topics, types of courses, reporting criteria—will be proposed by the Board in regulations to be reviewed by the Legislature in 2001.

A quick look at the highlights of the proposed regulations:

- All 12 hours must be in structured course study (reading magazine articles will not count).
- Twelve hours of carry-over will be allowed for a maximum of one year.
- Exemptions for first-time registrants, civilians serving on active duty in the military for 90 consecutive days or more, non-residents who must obtain comparable CE in another jurisdiction and hardship cases.
- The first report of CE obtained will be on renewal forms due by June 30, 2003.
- Noncompliance is considered a violation of the Architect Registration Law.

The entire text of the proposed regulations is printed below. We would appreciate hearing your comments and questions—by phone, e-mail, or fax.

## Text of the Proposed Regulations:

### Regulation 11-1. Definitions.

- (5) "Continuing Education Hour" means one (1) contact hour of participation in a continuing education activity.
- (6) "Contact hour" means a minimum of fifty (50) minutes of instruction.

### Regulation 11-8. Renewals.

- A. Certificates of Registration issued to individuals expire annually on June 30. They must be renewed annually for the following fiscal year by payment of the renewal fee and by reporting completion of the required continuing educa-

tion hours on or before July 1. Certificates shall become invalid after that date unless renewed.

- B. Certificates of Authorization issued to firms expire annually on December 31. They must be renewed annually for the following calendar year by payment of the renewal fee on or before January 1 and shall become invalid after that date unless renewed.
- C. Lapsed Certificates may be reinstated by the Board at any time during the remainder of the following year on demonstration of qualification and payment of the annual renewal fee plus late penalties. In case of failure to reinstate within a year from the date of expiration, the Certificate cannot be reissued except by a new application accompanied by the application fee and approval by the Board.

### Regulation 11-8.1. Continuing Education.

- A. These requirements shall apply to every South Carolina registered architect as a condition for renewal of registration on an annual basis.
- B. Exemptions: A registrant may be exempt from the continuing education requirements for one of the following reasons:
  - (1) A first-time new registrant by examination or reciprocity will be exempt for the first renewal.
  - (2) Registrant is a civilian who serves on active duty in the Armed Forces of the United States for a period of time exceeding ninety consecutive days during the annual report period.
  - (3) Registrants are non-residents of South Carolina and are required to obtain continuing education hours for license renewal by the licensing authority of any state in which he or she is registered. If the Board determines the continuing education requirements are substantially equivalent to those of South Carolina, the Board may accept a statement of compliance from the registrant.
  - (4) Hardship cases may be considered on an individual basis.
- C. Requirements.
  - (1) Each South Carolina Registered architect shall complete a minimum of twelve continuing education hours of structured course study each fiscal year.

- (2) Structured course study shall consist of participation in education activities presented by individuals or groups qualified by professional, practical, or academic experience to conduct courses of study.

- (3) Topics for the twelve continuing education hours shall meet the following requirements:

- (a) A minimum of eight continuing education hours shall include the study of relevant technical and professional architectural subjects related to safeguarding life, health, property, and promoting the public welfare.

- (b) A maximum of four continuing education hours may consist of elective topics related to any other area in the practice of architecture.

- (4) Each registrant shall submit, on a form provided by the board, a signed affidavit attesting to the fulfillment of continuing education requirements during the preceding period of one fiscal year ending June 30. The first report will be due before June 30, 2003. Reports will be due with each renewal thereafter. Carry-over of a maximum of twelve continuing education hours for one year is permitted.
- (5) Each affidavit may be subject to audit for verification of compliance with requirements. Registrants shall retain proof of fulfillment of requirements for a period of one year after submission in the event the affidavit is selected for audit.
- (6) The Board may disallow claimed credit for continuing education hours. The registrant shall have one hundred eighty calendar days after notification of disallowance of credit to substantiate the original claim or earn other continuing education credit which fulfills minimum requirements.
- D. Noncompliance and Sanctions. Failure to fulfill the continuing education requirements or to file the required annual report, properly completed and signed, shall be considered a violation of the Architectural Registration Law.

# NCARB Annual Meeting

At the annual meeting of the National Council of Architectural Boards (NCARB) in June, several actions were taken that could affect you and your colleagues. A summary follows; for detailed information, contact NCARB.

- Internship experience as a contract employee may be counted toward IDP under certain circumstances.
- Ten training units may be earned toward IDP for performing professional and community service of any kind when verified by the person in charge of the program.
- For NCARB certification under the Broadly Experienced Architect standard, education deficiencies may be satisfied by verification of 10 years of substantial architectural practice as a licensed architect in a U.S. jurisdiction.
- Unanimously passed a resolution to support the work of the Collateral

Internship Task Force regarding IDP, mentoring and education.

- Passed a resolution to oppose enactment of additional interior designer licensing laws, to monitor licensing efforts, to take action to oppose such efforts, and to continue to support boards with information with which boards may effectively oppose such efforts.

At this same meeting, Peter Steffian, FAIA, was elected President of NCARB. Previously he served as NCARB treasurer and first vice president. Steffian is chairman of Steffian Bradley Associates, Inc., in Boston, Mass.

Other officers for 2000-01 are: C. William Bevins, First Vice President, Charleston, WV; C. Robert Campbell, Second Vice President, Albuquerque, NM; Frank Guillot, Treasurer, Burlington, VT; and Robert A. Boynton, Secretary, Richmond, VA.

## Intern Development Program

Internship is a critical but often misunderstood period of time for emerging architects. Structured so as to maximize the training opportunities for graduates, internship is every bit as important as formal education and testing to the successful architect. That is the message the Board wanted to convey to architecture students at Clemson University, the state's only architecture school, during a convocation of fourth-year students and all graduate students in September. IDP enrollment packets were distributed to approximately 90 students, and applications were completed during the meeting. As in the past, funding for enrollment of fourth-year students (\$50) and payment of full fees for graduate students (\$265) was provided by the Board.

Besides enrolling students in IDP, the convocation provided an opportunity for straight talk about becoming an architect, the hurdles, the satisfactions, the seemingly endless requirements. Students are savvy, but their academic schedules require them to focus on the here-and-now; looking into

their future requires many choices and decisions, and sometimes confusion reigns. In this convocation, we talked about the Board's role versus the AIA's role; how IDP, NCARB, AIA, AIAS, and other scrambled letters affect their future; and that IDP shouldn't be about just "seat time" but, rather, about the quality of the experience.

Internship *is* important. By providing funding, the Board hopes to eliminate cost as an impediment to enrolling in IDP. By holding the convocation and accepting responsibility for processing the enrollment forms, Clemson University's School of Architecture hopes to emphasize their agreement that education plus meaningful internships are vital to future architects. Interns who benefited from this program last year say it made a difference—and that is what the Board hoped to hear.

## NCARB Publishes Two New Monographs

The National Council of Architectural Registration Boards recently released two new additions to its Professional Development monograph series: *Low Slope Roofing I* and *Professional Conduct*. *Low Slope Roofing I* is written to help a practitioner become more familiar with roofing terminology and concepts and more skilled in designing built-up roofing (BUR) systems. Built-up roofing, a type of low-slope roofing system, is specified on about 35 percent of new buildings in the U.S. today. This publication discusses the entire roof assembly: roof deck, vapor retarder, drainage, insulation and membrane materials. Specific topics include code requirements, design considerations, material options and installation techniques. The monograph was authored by Justin Henshell, AIA, NCARB, a partner at Henshell & Buccallero in Red Bank, N.J.

The successful completion of the quiz that accompanies each monograph equals 10 contact hours in Health, Safety and Welfare and 10 AIA Learning Units. # Disciplinary Actions

**Steven K. Bowman**, Registered Architect, Charlotte, NC, entered into a Consent Order with the Board in connection with his firm's involvement in a Group Home project in Rock Hill. At the time professional architectural services were rendered, neither Bowman nor his firm, **Perigon, P.A.**, were registered to practice in South Carolina. Sanctions imposed were a Public Reprimand, \$500 fine for Bowman, \$1,000 fine for Perigon, P.A., and a requirement to register the firm. The firm and Bowman are currently registered to practice in South Carolina.

**Lawrence G. David**, Registered Architect, Birmingham, AL, entered into a Consent Order with the Board based upon his firm's involvement in two hotel projects in Myrtle Beach. At the time professional architectural services were rendered, David's firm, **David & Company Architects, Inc.**, was not registered to practice in South Carolina. Sanctions imposed were a Public Reprimand, \$500 fine, and a requirement to register the firm. The firm is now registered to practice in South Carolina.

**Richard D.R. Chang**, Registered Architect, San Bruno, CA, entered into a Consent Order with the Board in connection with his firm's involvement in a clothing store project in Myrtle Beach. At the time professional architectural services were rendered, Chang's firm, **The Gap, Inc.**, was not registered to practice in South Carolina. Sanctions imposed by the Board were a Public Reprimand, \$500 fine, and a requirement to register the firm. The firm is now registered to practice in South Carolina; however, prior to obtaining its Certificate of Authorization from the Board, a **Cease and Desist Order** was issued to The Gap, Inc., for continued unlicensed practice of architecture in South Carolina.

**Thymie S. Latto**, Registered Architect, Charleston, and **Raymond Phillips**, unlicensed residential designer, Johns Island, entered into a Consent Order with the Board in connection with their firm's involvement in a single-family residence project on Seabrook Island. In the Order, the respondents admitted that their firm, **Design Group Joint Venture**, had provided professional architectural services in South Carolina from July 20, 1987, to April 28, 2000, without benefit of firm registration. The Board imposed sanctions of a Public Reprimand and \$500 fine. The firm is now registered to practice in South Carolina.

**HCSI** (Haselden CADD Services, Inc.), Spartanburg, SC, was issued a Cease and Desist Order for identifying itself as "architectural designers" on design documents offered for permit for a commercial project in Johnsonville, SC.

**Sherri F. Nester**, unlicensed principal, Charleston, SC, and her firm, **The Studio Architects, Inc.**, were issued a Cease and Desist Order for conveying the impression that Nester is a licensed architect.

Five **Letters of Caution** were issued to South Carolina registrants for unregistered firm matters and improper sealing of design documents.

Firm registrations expire **DECEMBER 31, 2000**. Renewal notices will be mailed in mid-November. If you do not receive your renewal form by early December, contact the Board office. We cannot be responsible for misplaced or mishandled mail, but we will promptly mail or fax another renewal form. **Remember to report the firm's change of address immediately upon relocation. If architects employed by the firm use the firm's mailing address, they must also notify the Board in writing before this change can be made to their individual file.**

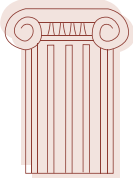
