There will be a "public comments" portion at each meeting during which persons in the audience can address the Board about any concerns or issues they may have. The Board members look forward to seeing you at these meetings.

## Message From Chairman David Bagwell

The Board meets the second Monday of every other month (January, March, May, July, September and November) in Columbia at the Board office. I have encouraged all licensees to attend these meetings because your input and ideas are important to the Board. In September, the Board will hold its meeting in **Greenville** and in November we will hold our meeting in **Charleston** in order to give licensees in the upper and lower part of the state an opportunity to attend. Please do. Dates and places are announced in a different portion of this newsletter.

The law requires all licensees to get their continuing education between January 1 and December 31 of the year preceding license renewal. In other words, to renew your license before March 10, 2000, you must get your continuing education between January 1, 1999 and December 31, 1999. There will be more than 200 continuing education classes taught during this time. Please do it before the first of the year. Don't put it off.

**A.** Yes, the cosmetologist could be fined and have his/her license revoked if he/she did hair for pay or reward in the home, or a portion of the home, which was not licensed as a salon.

If you know of anyone who is performing hair in their home and charging for their services, you may use the Complaint Form printed in this newsletter to make a complaint.

### **INSTRUCTIONS AND INFORMATION FOR COMPLAINT FORM**

Enclosed is a Board- or Commission-approved complaint form which must be completed with as much detail as possible.

1. In completing the form, you are referred to as the **complainant**. The individual or business you are filing a complaint against is referred to as the **respondent**.
2. **Please state all facts briefly and clearly**. Also, include names of all witnesses, addresses and phone numbers. Please include copies of any documents, records, statements or contracts that may assist us in the inquiry.
3. You may be required to appear at a hearing in this matter and testify under oath as to the facts in this complaint.
4. Upon completion, mail this complaint along with any attachments, to the following address:  
**S. C. Dept of Labor, Licensing and Regulation, Attn: Investigations Unit, P. O. Box 11329, Columbia, SC 29211-1329**

The South Carolina Department of Labor, Licensing and Regulation, along with the Boards and Commissions it administers, is mandated by the South Carolina Legislature to investigate any and all complaints. A trained investigator will conduct a preliminary inquiry into all complaints to determine the validity of the allegations. Information will be presented to the Board/Commission, or designee, in order to determine if a violation of the practice act has taken place. The complaint will be dismissed by the Board/Commission if no violation is found.

#### **If misconduct exists, two options are available to the respondent:**

1. **CONSENT ORDER:** The respondent admits a violation and voluntarily cooperates with the Board/Commission. The consent order may contain a sanction (private or public reprimand, probation, suspension or revocation) and/or a civil penalty (maximum \$5,000).
2. **ADMINISTRATIVE HEARING:** If a consent order cannot be negotiated, the respondent has a right to a hearing. The hearing would be held in Columbia in accordance with the South Carolina Administrative Procedures Act. The licensee will be served with a complaint (30 days in advance) detailing the alleged violation and a hearing notice to include a hearing time and date. The licensee may represent himself or herself or obtain counsel for the hearing. The Board/Commission will consider evidence presented during the hearing and render a decision as to the alleged violation.

The Board or Commission will produce a final order containing the dismissal notice or the sanction and civil penalty (if any) imposed by the Board or Commission. All appeals would be made to the South Carolina Administrative Law Judge, and thereafter, to the South Carolina Circuit Court. Appeals from the Circuit Court decisions would be made to the South Carolina Supreme Court.
